

THIS CONSENT AND REAFFIRMATION OF COLLATERAL AGREEMENT (this "Consent and Reaffirmation"), dated as of August 12, 2019 is executed by each of the undersigned Persons designated as a Grantor (each a "Grantor" and, collectively, the "Grantors"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION ("Wells Fargo"), as the administrative agent for and representative of (in such capacity herein called the "Secured Party") the lenders party to the Credit Agreement referred to below from time to time (each individually, a "Lender" and, collectively, the "Lenders"), any Hedge Banks (as defined in the Credit Agreement referred to below), and any Cash Management Banks (as defined in the Credit Agreement referred to below). Capitalized terms used but not defined herein shall have the meaning ascribed thereto in the Credit Agreement (as defined below).

RECITALS

A. POWDR CORP., a Delaware corporation ("Powdr"), BOREAL RIDGE CORPORATION, a California corporation ("Boreal"), KILLINGTON/PICO SKI RESORT PARTNERS, LLC, a Delaware limited liability company ("Killington"), MT. BACHELOR LLC, an Oregon limited liability company ("Mt. Bachelor"), PARLEYS RECREATION PARTNERS, L.L.C., a Utah limited liability company ("Parleys"), POWDR - COPPER MOUNTAIN LLC, a Delaware limited liability company ("Powdr-Copper"), POWDR - WOODWARD CA LLC, a Delaware limited liability company ("Powdr-Woodward CA"), POWDR - WOODWARD PA LLC, a Delaware limited liability company ("Powdr-Woodward PA") and, together with Powdr, Boreal, Killington, Mt. Bachelor, Parleys, Powdr-Copper, and Powdr-Woodward CA, each a "Borrower" and, collectively, the "Borrowers"), the Lenders, and Secured Party, as administrative agent for the Lenders, are parties to that certain Credit Agreement, dated as of August 3, 2015 (as amended, modified and/or supplemented prior to the date hereof the "Existing Credit Agreement"), pursuant to which the Lenders have provided to the Borrowers an extension of credit upon the terms and subject to the conditions set forth therein.

B. Secured Party and Grantors, have executed that certain Amended and Restated Collateral Agreement, dated as of October 25, 2016 (as amended, modified and/or supplemented prior to the date hereof the "Collateral Agreement").

C. Secured Party and Grantors, have executed that certain Amended and Restated Grant of Patent Security Interest, dated as of October 25, 2016 (as amended, modified and/or supplemented prior to the date hereof the "Patent Security Agreement").

D. Secured Party and Grantors, have executed that certain Amended and Restated Grant of Trademark Security Interest, dated as of October 25, 2016 (as amended, modified and/or supplemented prior to the date hereof the "Trademark Security Agreement") and, together with the Collateral Agreement and the Patent Security Agreement, the "Collateral Agreements").

E. The Borrowers, the Lenders and Secured Party have agreed to amend and restate the Existing Credit Agreement, pursuant to that certain Amended and Restated Credit Agreement, dated as of August 12, 2019 (the "Credit Agreement").

F. One of the conditions to the effectiveness of the Credit Agreement and the ongoing availability of the credit facilities thereunder is the execution and delivery by the Grantors of this Consent and Reaffirmation.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, each Grantor hereby agrees as follows:

I. *Reaffirmation.* Each Grantor hereby: (i) consents to the Credit Agreement; (ii) confirms that the Collateral Agreements remain in full force and effect; (iii) reaffirms its obligations under the Collateral Agreements; (iv) confirms the validity of Liens and assignments granted pursuant to the Collateral Agreements; (v) confirms that the Collateral Agreements and such Liens and assignments in connection therewith, and any other documents or instruments executed, filed or recorded in connection therewith, support or secure, and will continue to support or secure, the Secured Obligations, without interruption or impairment of any kind; (vi) reaffirms its waivers of each and every one of the defenses to such obligations as set forth in the Collateral Agreements; and (vii) reaffirms that its obligations under the Collateral Agreements are separate and distinct from the obligations of

any other party under the Credit Agreement and the other Loan Documents described therein.

The Schedules to the Trademark Security Agreement are hereby deleted in their entirety, and the Schedules on Exhibit C attached hereto are replaced therefor.

3. *No Other Modification or Waiver.* Except as expressly provided above, the execution, delivery and effectiveness of this Consent and Reaffirmation shall not modify the Collateral Agreement or operate as a waiver of any right, power or remedy of the Secured Party under the Collateral Agreement or any of the other Loan Documents, nor constitute a waiver of any provision of the Credit Agreement or any of the other Loan Documents.

4. *Governing Law.* This Guarantors' Consent and Reaffirmation shall be governed by and construed in accordance with the laws of the State of New York (including Section 5.1401 and 5.1402 of the General Obligation Law of the State of New York), without reference to any other conflict or choice of law principle thereof.

5. *Counterparts.* This Consent and Reaffirmation may be executed in any number of identical counterparts, any set of which signed by all the parties hereto shall be deemed to constitute a complete, executed original for all purposes.

6. *Loan Document.* This Consent and Reaffirmation shall be deemed to be a Loan Document under and as defined in the Credit Agreement.


