WHEREAS:

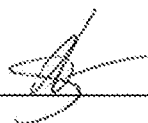
- (a) The Assignor is the proprietor of the trademarks in the **United States** as set out in the attached schedule marked "Annex A" (the "Trademarks"); and

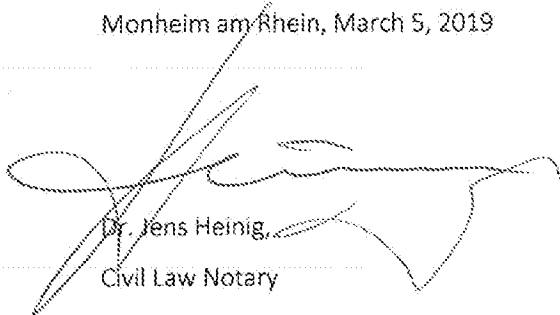
