
**RELEASE AND TERMINATION OF SECURITY AGREEMENT**

In consideration of the payment of all indebtedness and amounts secured by that certain Trademark Security Agreement made as of May 2, 2017 by and between Silicon Valley Bank, a California corporation with a principal place of business at 3003 Tasman Dr., HF150, Santa Clara, CA 95054 (the "Lender"), and Siftit, Inc., a Delaware corporation, with a principal place of business at 1 Glenlake Parkway, Suite 200, Atlanta, GA 30328 (the "Borrower"), which Trademark Security Agreement was filed with the United States Patent and Trademark Office on June 19, 2017, and recorded in Reel 6086, Frame 0466, of the Trademark Assignment Records, the Lender hereby releases and discharges all of its right, title and interest in and to the above-described Trademark Security Agreement, including the security interest and conditional assignment created and existing thereunder on the property described in and covered thereby, and reassigns to the Borrower any right, title and interest of the Lender in and to the "Collateral" described therein, including the right to recover for past infringement of any of the Collateral and the goodwill of the business in connection with which the Collateral is used and which is symbolized by any of the Collateral.
