WHEREAS, Samuelsohn Limited – Samuelsohn Limitee, a corporation incorporated under the laws of Canada with offices at 6930 Park Ave., Montreal, QC H3N 1W9 (the “**Debtor**”) is the owner of the trademarks set forth in Exhibit 1, as well as the underlying goodwill of said trademarks (collectively, the “**Trademarks**”);
