(iii) all rights to sue for past, present and future infringement or misappropriation of the Marks.

Assignor further covenants to execute all documents, papers, form and authorizations and take all actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks and the Products.

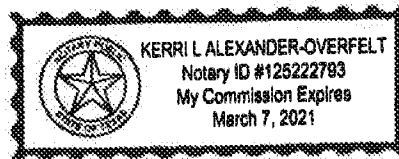
