THIS ASSIGNMENT is made on the 3 day of June 2019

BETWEEN

(1) **FIL LIMITED** a company incorporated and registered in Bermuda with company number 01462 whose registered office is at Pembroke Hall, 42 Crow Lane, Pembroke, Bermuda, HM19 (the "Assignor")

and

(2) **EIGHT ROADS HOLDINGS LIMITED** a company incorporated and registered in Bermuda with company number 35416 whose registered office is at Pembroke Hall, 42 Crow Lane, Pembroke, Bermuda, HM19 (the "Assignee")

BACKGROUND

- (A) The Assignor is the owner and registered proprietor of the Trade Marks and owns the intellectual property rights in the Materials (as defined below).
- (B) The Assignee is a subsidiary of the Assignor and the parties have agreed to assign the Trade Marks and the intellectual property rights in the Materials on the terms set out in this agreement.

AGREED TERMS

1. INTERPRETATION

The following definitions and rules of interpretation apply in this agreement.

1.1. Definitions:

"Assigned Rights": the Trade Marks, Domain Names and all the Intellectual Property Rights embodied in the Materials;

"Domain Names": the domain names listed in Schedule 3;

"Intellectual Property Rights": all copyright and neighbouring and related rights, trade marks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets), and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world;

"Materials": all works, documents, reports, records, papers, drawings, designs, transparencies, photos, graphics, logos, typographical arrangements, software programs, inventions, discoveries, developments,

improvements or innovations and all materials embodying them in whatever form, including but not limited to hard copy and electronic form and any other output of any kind whatsoever created or developed by the Assignor or the Assignee for the sole purpose of marketing, promoting, advertising and developing the Eight Roads brand and the Assignee's business, including the materials listed in Schedule 2; and

"Trade Marks": the registered trade marks and the applications as set out in Schedule 1.

- 1.2. Clause, Schedule and paragraph headings shall not affect the interpretation of this agreement.
- 1.3. The Schedules form part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedules.
- 1.4. Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.5. A reference to writing or written includes faxes and email.
- 1.6. Any words following the terms including, include, in particular, for example or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.
- 1.7. A person includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).

2. ASSIGNMENT

2.1 In consideration of the sum of \$1 (receipt of which the Assignor expressly acknowledges), the Assignor hereby assigns to the Assignee, with full title guarantee, all of its right, title and interest in and to the Assigned Rights, including:

- 2.1.1 the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Trade Marks;
- 2.1.2 all goodwill attaching to the Trade Marks relating to the goods or services for which the Trade Marks are registered or used; and
- 2.1.3 the right to bring, make, oppose, defend or appeal proceedings, claims or actions, and obtain relief and to retain any damages recovered, in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Rights, whether occurring before, on, or after the date of this agreement.

3. Further Assurance

The Assignor shall do or procure to be done all such further acts and things and execute or procure the execution of all such other documents, as the Assignee may from time to time reasonably require in order to give the Assignee the full benefit of this assignment, whether in connection with any registration of title or other similar right or otherwise.

4. WAIVER

No failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

5. VARIATION

No variation of this agreement shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

6. SEVERANCE

If any provision or part-provision of this agreement is or becomes invalid, illegal or unenforceable, it shall be deemed deleted, but that shall not affect the validity and enforceability of the rest of this agreement.

7. COUNTERPARTS

7.1 This agreement may be executed in any number of counterparts, each of which when executed shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

7.2 Transmission of an executed counterpart of this agreement by (a) fax or (b) email shall take effect as delivery of an executed counterpart of this agreement

8. GOVERNING LAW

This agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of the Island of Bermuda.







