CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, Assignor wishes to assign to Assignee Assignor's entire right, title and interest in the '661 Registration and all right, title and interest in Assignor's use of the BOBCAT mark including with tablet or handheld computers, computer docking stations, computer handles, and computer battery packs, together with any goodwill of the business in connection with which the BOBCATE mark is used;

WHEREAS, Assignee wishes to acquire the entire right, title and interest in and to the '661 Registration and associated trademark rights, together with the goodwill represented by the Assignor's use of the BOBCAT mark; and


WHEREAS, Assignor agrees that it will execute or arrange for execution by Assignor of such further assignment documents or other legal instruments as may be required to permit Assignee or its designee to obtain recordation of the assignment of the '661 Registration from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor agrees to sell, assign, and transfer to Assignee, its successors and assigns, and does hereby sell, assign, and transfer to Assignee, its successors and assigns, Assignor's entire right, title, and interest in and to the '661 Registration and associated trademark rights, and the goodwill of the business symbolized by the BOBCAT mark, as well as all rights to damages and profits, due or accrued, arising out of past alleged infringement of the BOBCAT mark, and the right to sue and recover for same.

This Assignment is made pursuant to that certain Settlement and Assignment Agreement effective as of July 24, 2019, by and between Assignor and Assignee (the "Agreement"). To the extent of any conflict between the terms of this Assignment and the Agreement, the terms of the Agreement shall prevail and control.
