INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT is dated as of August 13, 2019 (the “*IP Security Release*”) and executed and delivered by **COMMERZBANK FINANCE & COVERED BOND S.A.**, as security agent (in such capacity, the “*Security Agent*”) for the Secured Parties (as that term is defined in the Security Agreement dated as of December 22, 2014 (as amended, amended and restated, supplemented or otherwise modified through the date hereof, the “*Security Agreement*”) by and between Edlon, Inc. (the “*Grantor*”) and the Security Agent. All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement.

WHEREAS, pursuant to the Security Agreement Grantor granted to the Security Agent a security interest in and to all of such Grantor’s right, title and interest in and to the Intellectual Property set forth on Schedule A attached hereto (the “*IP Collateral*”).

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on February 13, 2015 on reel 034993 frame 0651;

WHEREAS, the Security Agent now desires to release its security interest in and to the Grantors’ right, title and interest in and to the IP Collateral identified in Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Security Agent and the Grantor hereby agree as follows:

SECTION 1. Release of Security Interest. The Security Agent does hereby release and convey to Grantor, without recourse, representation or warranty of any kind, all of the Security Agent’s right, title and interest in and to the Grantor’s right, title and interest in and to the Intellectual Property identified in Schedule A attached hereto.

SECTION 2. Execution in Counterparts. This IP Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this IP Security Release by facsimile will be as effective as delivery of a manually executed counterpart of this IP Security Release.



