**RELEASE OF  
TRADEMARK COLLATERAL AGREEMENT**

THIS RELEASE OF TRADEMARK COLLATERAL AGREEMENT ("Release"), dated as of August 21, 2019, is made by FIFTH THIRD BANK, an Ohio banking corporation, as Administrative Agent for the benefit of the Secured Creditors ("Agent"), and is as follows:

WHEREAS, Agent and WHOLESOME SWEETENERS, INCORPORATED, a Delaware corporation ("Debtor") are parties to that certain Trademark Collateral Agreement, dated as of August 29, 2014, which was recorded with The United States Patent and Trademark Office on September 3, 2014, in its records at Reel 5355, Frame 0816, as amended by the First Amendment to Trademark Collateral Agreement, dated as of March 1, 2019, which was recorded with The United States Patent and Trademark Office on March 11, 2019, in its records at Reel 6596, Frame 0150 (as amended, the "Agreement"). Capitalized terms used, but not defined, herein shall have the meanings given to them in the Agreement;

WHEREAS, the Agreement granted to Agent, for the benefit of the Secured Creditors, a continuing security interest in and to, and Lien on (collectively, the "Trademark Collateral"):

(i) Each trademark, trademark registration, and trademark application listed on Schedule I hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and


(ii) All proceeds of the foregoing, including without limitation any claim by the Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule I hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages; and
