**PARTIAL RELEASE OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this “Release”) is made as of August 20, 2019 (the “Effective Date”), by MEDLEY CAPITAL LLC, a Delaware limited liability company, in its capacity as collateral agent for the benefit of the Secured Parties (the “Collateral Agent”), in favor of CSF, LLC, a New Jersey limited liability company and AERIALINK LLC, a Delaware limited liability company (each a “Grantor” and, collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 16, 2017, by the Grantors in favor of the Collateral Agent (the “Trademark Security Agreement”), the Grantors pledged and granted to the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademark Collateral of the Grantors including those trademarks specifically listed on Schedule I hereto (the trademarks identified on Schedule I hereto, the “Released Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 16, 2017 at Reel 6206, Frame 0981; and

WHEREAS, the Collateral Agent wishes to terminate and release its lien on and security interest in and to the Released Trademarks and reassign and retransfer to the Grantor all of the Collateral Agent’s rights, title and interest in and to the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, for the benefit of the Secured Parties, hereby agrees as follows:

The Collateral Agent hereby terminates and releases its security interest in and to the Released Trademarks. If and to the extent the Collateral Agent has acquired any right, title or interest in, to or under any of the Released Trademarks, it hereby irrevocably reassigns and retransfers all such right, title and interest to the Grantor.


Nothing contained in this Release shall be construed as a termination, release, retransfer or reassignment of any security interest, if any, or any right, title and interest which the Collateral Agent may have in the Trademark Collateral which has not been specifically identified on Schedule I hereto or any other collateral described in the Trademark Security Agreement or otherwise.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.
