

Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee any and all rights, title, and interests Assignor holds, or may hold, in and to the Assigned Trademarks, together with all rights derived therefrom, including statutory, common law and contractual rights, and any and all goodwill connected with and symbolized by, in, to, and under the Assigned Trademarks, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors and assigns to the end of the term or terms for which the Assigned Trademarks are granted, or reissued, or extended as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, and in and to all income, royalties, damages, and payments now or hereafter due or payable with respect to the Assigned Trademarks, including in and under all causes of action (either in law or in equity), and the right to sue, counterclaim, and recover for past, present, and future infringement of the rights assigned under this Assignment.
2. If applicable, the Parties hereby request and authorize the applicable foreign authorities to record Assignee as the assignee and owner of the Assigned Trademarks.
3. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns.
