**SCHEDULE A**

**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**  
**(Recordable)**

This Recordable Intellectual Property Assignment Agreement (“Assignment Agreement”) is dated and effective as of the 19<sup>th</sup> day of August 2019 by and between Sparta Nutrition, LLC (“**Nutrition**, Assignor”) and Sparta Beverage, LLC, a Delaware limited liability company (“**Beverage**, Assignee”).

U.S. Trademark Application Serial No. 87836027 for the SPARTA NUTRITION trademark; and All rights of any kind whatsoever of Assignor accruing under the Assigned Trademarks under the applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, including any and all rights to sue and collect damages, royalties, or payments for past, present, and future infringement, misappropriation, or other violation of the Assigned Trademarks.

**Recordation.** The parties authorize the Commissioner for Trademarks and any other similar authority anywhere in the world to record and register this Agreement upon request of either party.

**Successors and Assigns.** This Agreement shall be binding upon and shall inure to the benefit of the parties and their respective successors and assigns.
