**TRADEMARK SALE & ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this "Assignment"), dated as of August 20<sup>th</sup>, 2019 confirms an Agreement made on May 2<sup>nd</sup>, 2019 by and between The Buzzed Bull Holdings, LLC, an Ohio limited liability company ("Assignor"), and Buzzed Bull Franchising, LLC, an Ohio limited liability company ("Assignee").

WHEREAS, the Assignor is the registered owner of the design mark, identified as "Buzzed Bull Creamery," filed with the United States Patent and Trademark Office under Registration Number 5584036 (the "Trademark"), and is desirous of transferring all rights, ownership and control of the Trademark to Assignee; and,

WHEREAS, the Assignee is desirous of obtaining all rights, ownership and control of the Trademarks for its own use and purposes;

NOW, THEREFORE, the parties agree as follows:

1. Representations and Warranties. The Assignor hereby represents and warrants that it is the registered owner of the Trademarks; it is not actually aware of any litigation or any other dispute existing from or relating to the Trademark; and that the Assignor will not engage in any action that will be detrimental to the validity of the Trademarks after the completion of the assignment.
2. Registration Fees. The registration and all fees for the assignment of the registered owner of the Trademarks shall be undertaken by the Assignee.
3. Transfer of Trademark. In consideration of \$10.00 and other good and valuable consideration, the receipt and sufficiency being acknowledged, the Assignor hereby sells, assigns and transfers all of Assignor's rights, title and interest in and to the Trademark, including the entire interest and goodwill, to the Assignee and the Assignee hereby accepts all rights, ownership and control of the Trademark.
4. Applicable Law. The validity, interpretation and implementation of this Agreement shall be governed by the laws of the State of Ohio.




