**RELEASE OF SECURITY INTEREST  
IN CERTAIN TRADEMARK AND PATENT COLLATERAL**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK AND PATENT COLLATERAL, dated as of August 21, 2019 (this “Release”), is made by **U.S. BANK NATIONAL ASSOCIATION**, as collateral agent pursuant to the Indenture (as defined in the Security Agreement) (in such capacity, the “Collateral Agent”), in favor of **IHM IDENTITY, INC.** (“Trademark Grantor”), with respect to the Released Trademarks and **IHEARTMEDIA MANAGEMENT SERVICES, INC.** (“Patent Grantor”), with respect to the Released Patents (collectively, the Trademark Grantor and Patent Grantor are the “Grantors”), as follows.

**WITNESSETH**

WHEREAS, the Grantors are party to a Security Agreement dated as of August 7, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Security Agreement”) in favor of the Collateral Agent pursuant to which the Grantors executed and delivered the trademark security agreements and patent security agreements described below;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of August 7, 2019, and recorded with the U.S. Patent and Trademark Office on August 9, 2019, at Reel/Frame No. 6717/0001 and as corrected at Reel/Frame No. 6722/0098 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Trademark Security Agreement”), Trademark Grantor granted to the Collateral Agent a security interest in all right, title or interest in, to and under, the Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto;

WHEREAS, the trademark registrations and applications set forth on Schedule A are collectively, the “Released Trademarks”;

WHEREAS, pursuant to the Patent Security Agreement, dated as of August 7, 2019, and recorded with the U.S. Patent and Trademark Office on August 9, 2019, at Reel/Frame No. 050017/0882 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Patent Security Agreement”), Patent Grantor granted to the Collateral Agent a security interest in all right, title or interest in, to and under, the Collateral (as defined in the Patent Security Agreement), including, without limitation, the United States patents and patent applications set forth on Schedule B attached hereto;

WHEREAS, the patents and patent applications set forth on Schedule B are collectively, the “Released Patents”;

WHEREAS, Grantors have requested that the Collateral Agent release its security interest in the Released Trademarks and Released Patents;

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in the Released Trademarks and Released Patents as provided in this Release;

NOW, THEREFORE, the Collateral Agent, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without representation or warranty of any kind or nature, and at Grantors' sole cost and expense, hereby terminates, cancels, discharges and releases its security interest in all right, title and interest in, to or under the Released Trademarks and Released Patents.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release at Grantors' sole cost and expense.
