NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

August 22, 2019

WHEREAS, **BNP Paribus** (formerly known as Banque Nationale de Paris; “BNP”) was a party to that certain Third Amended and Restated Credit Agreement, dated as of December 1, 2002, among **Sarcom, Inc.**, certain financial institutions and other institutional lenders party thereto (the “Lenders”) and BNP, as amended, restated, supplemented or otherwise modified from time to time (the “Credit Agreement”);

WHEREAS, Sarcom previously granted BNP a security interest in certain trademarks listed on Schedule 1 attached hereto (the “Trademark Collateral”) in order to secure Sarcom’s prompt payment and performance of its obligations under the Credit Agreement;

WHEREAS, pursuant to that certain Agreement, dated as of June 18, 2004, among the Lenders (the “June 18th Agreement”), (i) BNP resigned as agent under the Credit Agreement and other Loan Documents (as defined in the Credit Agreement) and (ii) **Patriarch Partners Agency Services, LLC** (“Patriarch”) was appointed, and accepted such appointment, as successor agent under the Credit Agreement and the other Loan Documents;

WHEREAS, pursuant to the June 18th Agreement, (i) BNP agreed to transfer to Patriarch all items of Collateral (as defined in the Credit Agreement), including, without limitation, its security interests in the Trademark Collateral, (ii) Sarcom consented to such transfer of the security interests in the Trademark Collateral and (iii) thereafter BNP and Patriarch effectuated such assignment and transfer;

WHEREAS, BNP’s security interest in the Trademark Collateral was recorded with the United States Patent and Trademark Office (the “USPTO”) on November 19, 1996, under Reel/Frame 1530/0816, and the transfer and assignment of such security interest from BNP to Patriarch (the “Assignment”) was recorded with the USPTO on September 22, 2004, under Reel/Frame 3058/0436; and


WHEREAS, Patriarch wishes to provide a document suitable for recording in the USPTO the release, relinquishment and discharge of its liens on and security interest in the Trademark Collateral, and the goodwill associated therewith;

NOW, THEREFORE, in consideration of and for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Patriarch hereby terminates, cancels, relinquishes, releases and discharges all liens and security interests it has or may have in the Trademark Collateral listed on Schedule 1 attached hereto under or in connection with the Credit Agreement or the Assignment.
