TERMINATION OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT**, effective as of August 21, 2019, is made by Old ANR, LLC, a Delaware limited liability company (as successor by conversion to Alpha Natural Resources, Inc.), Dickenson-Russell Coal Company, LLC, a Delaware limited liability company, DFDSTE, LLC, a Delaware limited liability company (as successor by conversion to DFDSTE Corp., which was f/k/a Dry Systems Technologies, Inc.), Paramount Coal Company Virginia, LLC, a Delaware limited liability company, Appalachia Holding Company, LLC, a Virginia limited liability company (as successor by conversion to Appalachia Holding Company, which was f/k/a A.T. Massey Coal Company, Inc.), and Old ANR, LLC, a Delaware limited liability company (as successor by conversion to Alpha Natural Resources, Inc., which is successor by merger to Foundation Coal Corporation) (“Pledgors”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, each Pledgor granted to **Citicorp North America, Inc.**, as Collateral Agent (the “Secured Party”), for the ratable benefit of the Pledgors a security interest in and to certain intellectual property of such Grantor, and the following agreements were executed and delivered by certain of the Grantors in favor of the Collateral Agent (each as amended, amended and restated, supplemented or otherwise modified from time to time): that certain Guarantee and Collateral Agreement, dated as of July 31, 2004 by an between Dickenson-Russell Coal Company, LLC, Paramount Coal Company Virginia, LLC and the Collateral Agent; that certain Amended and Restated Guarantee and Collateral Agreement, dated June 1, 2011 by and between Alpha Natural Resources, Inc., Dry Systems Technologies, Inc., Dickenson-Russell Coal Company, LLC, Paramount Coal Company Virginia, LLC, A.T. Massey Coal Company, Inc, and the Collateral Agent; and that certain Amended and Restated Guarantee and Collateral Agreement dated June 1, 2011 by and between Alpha Natural Resources and the Collateral Agent.

WHEREAS, (i) the Trademark Security Agreement dated July 31, 2009 was recorded in the United States Patent and Trademark Office on August 3, 2009 at Reel 004035 and Frame 0655, (ii) the Trademark Security Agreement dated June 1, 2011 was recorded in the United States Patent and Trademark Office on June 1, 2011 at Reel 004552 and Frame 0227, (iii) the Trademark Security Agreement dated May 20, 2014 was recorded in the United States Patent and Trademark Office on February 23, 2015 at Reel 005464 and Frame 0489.

WHEREAS, Pledgors granted to Secured Party a continuing security interest in all of Pledgor’s right, title and interest in, to and under all Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks listed in Schedule A attached hereto.

WHEREAS, on July 12, 2016, the United States Bankruptcy Court for the Eastern District of Virginia, Richmond Division, entered its Order Confirming Second Amended Joint Plan of Reorganization of Debtors and Debtors in Possession, as Modified in that certain bankruptcy proceeding styled In re: Alpha Natural Resources, Inc., et al., Case No. 15-33896 (KRH) (hereinafter the “Bankruptcy Case”), confirming the Second Amended Joint Plan of Reorganization of Debtors and Debtors in Possession (hereinafter the “Plan”).

WHEREAS, the Plan became effective on July 26, 2016 (hereinafter the “Effective Date”), and the Pledgors emerged from the Bankruptcy Case on the Effective Date as the “Reorganized Debtors.”

WHEREAS, Section IV.Q of the Plan provides, in part, “all liens [as defined therein] against the property of any Estate, [as defined therein], will be deemed fully released and discharged, and all of the right, title, and intent of any holder of such liens, . . . , will revert to the applicable Reorganized Debtor, [as defined therein], and its successor and assigns.”

WHEREAS, Section IV.Q of the Plan further provides “(a) the holders of such Liens will be authorized and directed to release any collateral or other property of the Estates held by such holder and to take such actions as may be requested by the Reorganized Debtors to evidence the release of such Lien, including the execution, delivery, filing or recording of such releases as may be requested by the Reorganized Debtors; and (b) the Reorganized Debtors shall be authorized to execute and file on behalf of the creditors Form UCC-3 termination statements or such other forms as may be necessary or appropriate to implement the provisions of this Section IV.Q.”

WHEREAS, pursuant to, and in accordance with, the authority granted under Section IV.Q of the Plan, the Reorganized Debtors desire to release all Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks listed in Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the liens and security interests in the Trademark Collateral, including the trademarks listed in Schedule A, are hereby released and terminated.
