

TERMINATION OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT**, effective as of <u>August</u> <u>21</u>, 2019, is made by Old ANR, LLC, a Delaware limited liability company (as successor by conversion to Alpha Natural Resources, Inc.), Appalachia Holding Company, LLC, a Virginia limited liability company (as successor by conversion to Appalachia Holding Company), Dickenson-Russell Coal Company, LLC, a Delaware limited liability company (as successor by conversion to DFDSTE, LLC, a Delaware limited liability company (as successor by conversion to DFDSTE Corp., which was f/k/a Dry Systems Technologies, Inc.), and Paramont Coal Company Virginia, LLC, a Delaware limited liability company ("Pledgors").

WHEREAS, pursuant to that certain Security Agreement dated as of May 20, 2014, the "Security Agreement") and the Trademark Security Agreement dated May 20, 2014 (the "Trademark Security Agreement"), Pledgors granted to Wilmington Trust, National Association, as Notes Collateral Agent (the "Secured Party"), a continuing security interest in all of Pledgor's right, title and interest in, to and under all Collateral (as defined in the Trademark Security Agreement), including the trademarks listed in Schedule A.

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on May 23, 2014 at Reel 005285 and Frame 0988.

WHEREAS, on July 12, 2016, the United States Bankruptcy Court for the Eastern District of Virginia, Richmond Division, entered its Order Confirming Second Amended Joint Plan of Reorganization of Debtors and Debtors in Possession, as Modified in that certain bankruptcy proceeding styled In re: Alpha Natural Resources, Inc., et al., Case No. 15-33896 (KRH) (hereinafter the "Bankruptcy Case"), confirming the Second Amended Joint Plan of Reorganization of Debtors and Debtors in Possession (hereinafter the "Plan").

WHEREAS, the Plan became effective on July 26, 2016 (hereinafter the "<u>Effective Date</u>"), and the Pledgors emerged from the Bankruptcy Case on the Effective Date as the "Reorganized Debtors."

WHEREAS, Section IV.Q of the Plan provides, in part, "all liens [as defined therein] against the property of any Estate, [as defined therein], will be deemed fully released and discharged, and all of the right, title, and intent of any holder of such liens, . . . , will revert to the applicable Reorganized Debtor, [as defined therein], and its successor and assigns."

WHEREAS, Section IV.Q of the Plan further provides "(a) the holders of such Liens will be authorized and directed to release any collateral or other property of the Estates held by such holder and to take such actions as may be requested by the Reorganized Debtors to evidence the release of such Lien, including the execution, delivery, filing or recording of such releases as may be requested by the Reorganized Debtors; and (b) the Reorganized Debtors shall be authorized to execute and file on behalf of the creditors Form UCC-3 termination statements or such other forms as may be necessary or appropriate to implement the provisions of this Section IV.Q."

WHEREAS, pursuant to, and in accordance with, the authority granted under Section IV.Q of the Plan, the Reorganized Debtors desire to release all Collateral (as defined in the Trademark Security Agreement), including the trademarks listed in Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the liens and security interests in the Collateral, including the trademarks listed in Schedule A, are hereby released and terminated.
