(b) the right to secure registrations therein in Assignee's own name and to secure renewals and extension of the registration and application for registration in the United States of America or any other country; and


(c) the right to determine, in Assignee's sole discretion whether or not any registration or application for registration of the Mark shall be preserved and maintained or registered.
