- (4) ASSIGNOR shall, at the expense of ASSIGNEE, its successors and assigns, execute all papers and perform such other acts (and use its best efforts to require its officers and employees to do the same) as may be reasonably necessary to give ASSIGNEE, its successors and assigns, the full benefit of this Assignment.
- (5) ASSIGNOR represents and warrants that it has the full and unencumbered right to execute and provide the assignment, transfer, and conveyance set forth herein and that there are no licenses or other rights granted in favor of any other person or entity in or to the intellectual property referenced herein.

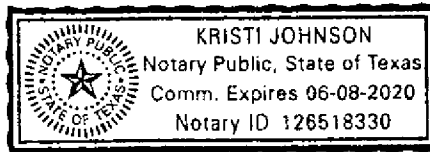

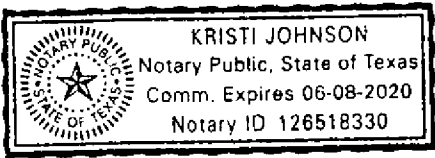
