**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of August 26, 2019, is made by and among North Shore Community Bank & Trust Company, an Illinois state chartered bank (the "Grantee"), in favor of Delve LLC, a limited liability company of Missouri (the "Grantor") as follows:

WHEREAS, Grantor and Grantee acknowledge that the Trademark Security Agreement, dated as of March 28, 2014 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on April 1, 2014 at Reel/Frame No. 5248/0438, was recorded in error against U.S. Registration No. 4422960 for CHEFSTEPS (the "Registration"), set forth in Schedule A attached hereto, and that neither Grantor nor Grantee have any right, title or interest in and to the Registration that rightfully belongs to CHEFSTEPS, INC.


WHEREAS, the Grantor has requested that the Grantee release its Lien on and continuing security interest in, all right, title and interest in and to the Registration, to restore ownership to CHEFSTEPS, INC.

NOW, THEREFORE, the Grantee, without recourse, representation or warranty and at the Grantee's sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in the Registration, and all of the goodwill of the business connected with the use of, and symbolized by the Registration, and any right, title and interest of the Grantee in the Registration shall hereby terminate, cease and become void.

The Grantee agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Grantee's security interest in the Registration (without recourse, representation or warranty and at the Grantee's sole cost and expense).
