RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of August 23, 2019 by WELLS FARGO STRATEGIC CAPITAL, INC., as lender (in such capacity, the "Lender").

WITNESSETH:

WHEREAS, RVR, INC., a Florida corporation ("RVR") and CRUISE AMERICA, INC., a Florida corporation ("Cruise America" and together with RVR, each a "Grantor" and, collectively, the "Grantors") executed that certain Second Lien Intellectual Property Security Agreement, dated as of January 5, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Lender, pursuant to which the Grantors granted a security interest to the Lender in certain trademarks and other intellectual property of Grantors; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 6245, Frame 0151 on January 8, 2018; and

WHEREAS, the Lender has agreed to release all its liens on the trademarks and trademark applications of the Grantors identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.


NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Lender's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.

For the avoidance of doubt, this Release does not affect and does not relate to (i) that certain Second Amended and Restated Credit Agreement, dated on or about January 5, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "First Lien Credit Agreement"), among Grantors, Cruise Canada, Inc., a corporation organized under the laws of Canada and Wells Fargo Bank, National Association, (ii) any other Loan Documents (as defined in the First Lien Credit Agreement) or (iii) any grants of security interest in connection therewith.
