RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of August 27, 2019 (this “Release”) is made by MIDCAP FINANCIAL TRUST, as administrative agent (in such capacity, the “Administrative Agent”) under that certain Trademark Security Agreement, dated as of February 26, 2018 (the “Trademark Security Agreement”) among GULF COAST PAIN CONSULTANTS, LLC, a Florida limited liability company (the “Grantor”) and the Administrative Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on February 26, 2018 at Reel 6279, Frame 0953, the Grantor granted to the Administrative Agent a security interest in all of Grantor’s right, title and interest in, to and under its registered and applied for Trademarks and all IP Licenses, including those set forth on the attached Schedule 1 (the “Trademark Collateral”); and

WHEREAS, in connection with satisfaction in full of that certain Credit and Guaranty Agreement, dated as of February 26, 2018 (as amended, restated, supplemented and/or modified from time to time), by and among the Grantor, the Administrative Agent and the other parties from time to time party thereto, the Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation, warranty or other assurance of any kind by Administrative Agent as to Administrative Agent’s rights in the Trademark Collateral or the condition or value of the Trademark Collateral, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral, and (d) authorizes Grantor or any of its authorized representatives to file this Release with the United States Patent and Trademark Office or any other applicable governmental office.
