**TERMINATION AND RELEASE OF
ABL SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of ABL Security Interest in Trademark (“Trademark Release”) is made as of August 27, 2019, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as agent (the “Collateral Agent”) in favor BARNETT OUTDOORS, LLC, a Florida limited liability company (collectively, the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, the Grantor, among others, entered into a certain Trademark Security Agreement, dated June 11, 2015 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on June 12, 2015 at the United States Patent and Trademark Office (the “USPTO”) at Reel 5551, Frame 0363;

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in the RAZR mark in connection with “Archery bows; Archery equipment, namely, broadheads; Crossbows,” as U.S. Registration No. 5443456 (the “Trademark”);

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark as herein provided;

WHEREAS, the Grantor has requested that the Collateral Agent execute and deliver this Trademark Release to evidence the release of the Collateral Agent’s security interest in the Trademark for filing and recordation with the USPTO;

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders and other holders of the Security Interest, hereby releases, terminates and discharges any and all of its security interest in, to, or under the Trademark, together with the goodwill symbolized by the mark, and any and all rights that the Grantor has obtained in such mark and all other rights appurtenant thereto, if any, including, but not limited to, all common law rights, trade name rights, causes of action , and the right to recover for past infringement, concurrent with the transfer of certain tangible assets as indicia of said goodwill that the Collateral Agent may have in such intellectual property, including the Security Interest. Any right, title, or interest of the Collateral Agent in the Trademark shall hereby cease and become void.
