RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 23, 2019 (the "Release"), is made by TPG SPECIALTY LENDING, INC., as the Administrative Agent and Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Grantee"), in favor of 33 MILE RADIUS LLC, an Ohio limited liability company (the "Grantor").

WITNESSETH

WHEREAS, the Grantor and the Grantee entered into that certain Pledge and Security Agreement, dated as of March 7, 2017 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Grant of A Security Interest --Trademarks, dated as of March 14, 2019 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on March 14, 2019 at Reel/Frame No. 6591/0729, pursuant to which the Grantor granted to the Grantee, and granted to the Grantee for the benefit of the Secured Parties (as such term is defined in the Security Agreement) a continuing security interest in all right, title and interest of the Grantor in, to and under the Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantor has requested that the Grantee release its security interest in all right, title and interest in, to and under the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Grantee hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Collateral, including the trademark application set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Grantee may have obtained in, to and under the Collateral under the Security Agreement and the Trademark Security Agreement.
