## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Grantor has requested that the Grantee release its security interest in all right, title and interest in, to and under the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Grantee hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Collateral, including the trademark registration set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Grantee may have obtained in, to and under the Collateral under the Security Agreement and the Trademark Security Agreement.
