NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR had used the Trademarks and acquired goodwill associated with and symbolized by the Trademarks and had not abandoned the same;



WHEREAS, ASSIGNOR did assign, convey, transfer, set over and grant, and wishes to confirm its assignment, conveyance, transfer, set over and grant to ASSIGNEE, as of the Effective Date of this Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Trademarks worldwide, along with the goodwill and business associated therewith, and certain tangible assets as indicia of said goodwill.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirms the assignment to ASSIGNEE of all rights, title, and interest as ASSIGNOR may possess in and to the Trademarks, together with the goodwill symbolized by the same, concurrent with the transfer of certain tangible assets as indicia of said goodwill and the business associated with the Trademarks.
