**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 23, 2019 ("Release"), is made by Bank of America, N.A., as Collateral Agent ("Collateral Agent") in favor of Gowan Company, L.L.C., an Arizona limited liability company ("Grantor").

WHEREAS, pursuant to that certain Amended and Restated Security and Pledge Agreement dated as of December 28, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Collateral Agent, and others party thereto, and the Collateral Assignment of Marks dated as of March 31, 2016 by and among the Grantor and Collateral Agent ("Trademark Security Agreement"), Grantor collaterally assigned and transferred to Collateral Agent and granted to Collateral Agent a security interest in all of Grantor's present and future right, title and interest in and to the Marks, with the goodwill of the businesses symbolized by the Marks and the registrations thereof, and all renewals and extensions of any of the foregoing and all proceeds thereof (collectively, the "Trademark Collateral"); and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on June 30, 2016 at Reel 5825 Frame 0094.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the collateral assignment and transfer and security interest in Grantor's present and future right, title and interest in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
