TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (“**Trademark Assignment**”), dated as of July 18, 2019, is made by Wanderlust Holdings, LLC (“**Assignor**”), a Delaware Limited Liability Company, located at 26 Dobbin Street, 3rd Floor, Brooklyn, New York 11222, in favor of Wanderlust Products Pty Ltd (“**Assignee**”), a proprietary limited company organized in Australia, located at Level 2, 6 Palmer Parade, Cremorne, Victoria 3121, Australia.

WHEREAS, under the terms of that certain Assignment, Co-Operation and Non-Confusion Agreement between Assignor and Assignee, effective as of even date herewith, Assignor has conveyed, transferred, and assigned to Assignee, among other assets, certain intellectual property of Assignor; and

WHEREAS, Assignor and Assignee have agreed to execute and deliver this Trademark Assignment, for recording with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s right, title, and interest in and to:

a) the trademark registrations set forth on Schedule 1 hereto and all issuances, extensions, and renewals thereof (the “**Assigned Trademarks**”), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks; and

b) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.


2. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement.


