## GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS



This Grant has been given in conjunction with the security interest granted to the Administrative Agent under the Security Agreement, and the provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.
