**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of November 12, 2014, by BANK OF AMERICA, N.A., as administrative agent ("Agent") for itself and various other lenders ("Lenders"), in favor of HEALTHPLAN HOLDINGS, INC., a Delaware corporation ("HPHI") and ZENITH AMERICAN HOLDING, INC. (f/k/a Health Holdings, Inc.), a Delaware corporation ("Zenith" and together with HPHI, collectively, "Grantor").

**WITNESSETH:**

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 18, 2011 made by HPHI and Zenith in favor of Agent for the benefit of Lenders, HPHI and Zenith granted a security interest in certain of their trademarks and service marks listed on Schedule I attached hereto (collectively, the "Trademarks") to Agent for the benefit of Lenders to secure certain debts and obligations owing from, inter alia, Grantor to Agent and Lenders;

WHEREAS, Grantor has requested that Agent (a) terminate and release the liens and interests of Agent in the Trademarks, and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and


WHEREAS, Agent has agreed to such release and termination;


