**AMENDED AND RESTATED CONFIRMATION OF SECURITY INTEREST  
IN U.S. TRADEMARKS**

This Confirmation is dated for reference August 30, 2019.

WHEREAS:

A. Seaspan ULC (the "**Owner**") is the owner of the trademarks set forth in Exhibit "A" and the registrations and applications for the trademarks identified therein (collectively, the "**Trademarks**");

B. Pursuant to a second amended and restated credit agreement dated for reference August 30, 2019 (as amended, restated or replaced from time to time, the "**Credit Agreement**") between the Owner, as borrower, the Institutions named therein, as lenders (collectively, the "**Lenders**") and The Toronto-Dominion Bank, as administration agent (the "**Agent**"), the Lenders have agreed to establish for the Owner certain credit facilities, all as more particularly described in the Credit Agreement;

C. As security for, *inter alia*, all present and future debts and liabilities of the Owner under the Credit Agreement, the Owner has executed a Debenture dated for reference February 18, 2015, as assigned by Computershare Trust Company of Canada to the Toronto-Dominion Bank, in its capacity as collateral agent for the Agent and the Lenders (the "**Collateral Agent**"), as amended by a modification dated for reference August 30, 2019, pursuant to which, *inter alia*, the principal amount was increased to C\$500,000,000, and extended by an extension dated August 30, 2019 (as so assigned, modified and extended, and as may be further amended, modified, replaced or extended from time to time, the "**Debenture**") pursuant to which the Owner has granted to the Collateral Agent a security interest in the Trademarks;

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged, the Owner confirms the grant to the Collateral Agent pursuant to the Debenture of a security interest in and to the Trademarks, as security for the "Loan Obligations" (as defined in the Debenture).


