**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS is effective this 3rd day of September 2019, by and between The Wolf Organization, LLC, a Delaware limited liability company (f/k/a The Wolf Organization, Inc., a Delaware corporation), (the “**Grantor**”) and MANUFACTURERS AND TRADERS TRUST COMPANY, in its capacity as Administrative Agent (the “**Lender**”).

WHEREAS, Grantor entered into a Trademark Security Agreement with the Lender, dated May 29, 2015 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to said Trademark Security Agreement, Grantor granted the Lender a security interest in all its right, title, and interest to its IP Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademarks listed at **Schedule A** (collectively, the “**Marks**”), among other collateral;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 1, 2015 at Reel 5526, Frame 0877, and a corrective assignment updating the typographical error in the assignor name was recorded in the United States Patent and Trademark Office on June 25, 2015, at Reel 5563, Frame 0963 (the “**Corrective Assignment**”, and together with the Trademark Security Agreement, collectively the “**United States Trademark Security Agreements**”);


WHEREAS, the Lender desires to release, terminates, and reassign to Grantor its security interest in and to the Marks pledged pursuant to the United States Trademark Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender hereby releases and terminates its security interest in and to the Marks and reassigns any and all interests it may have in such Marks to Grantor.


