ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "Assignment"), is made as of April 15, 2019, by CINEFLIX MEDIA INC., a corporation incorporated under the laws of Canada maintaining a place of business at 3510 Saint-Laurent Blvd., Suite 202, Montreal, Quebec, Canada H2X2V2 (in such capacity, "Assignor"), to SCOTT BROTHERS ENTERTAINMENT INC., a corporation continued under the laws of the Province of Ontario with its principal place of business at 6 Curity Avenue, Toronto, Ontario, M4B 1X2] maintaining a place of business at 8022 S. Rainbow Blvd., Suite 421, Las Vegas, Nevada 89139 ("Assignee").

WHEREAS, pursuant to an asset transfer agreement between the Assignor and the Assignee of even date herewith (the "Agreement"), Assignor has assigned *inter alia* all of its right, title and interest in and to the trademarks and the applications and registrations therefor listed on Exhibit A (collectively, the "Trademarks");

AND WHEREAS the Assignor remains the recorded owner of the Trademarks on the Canadian Trademarks Register;

AND WHEREAS Assignee has requested that Assignor execute an assignment suitable for recording, effective immediately, evidencing that Assignee is the successor-in interest of the entire right, title and interest in and to the Trademarks and that Assignor has no further interest therein;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:

1. Assignor hereby assigns and transfers to Assignee the entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith, all rights of action resulting from prior infringement or other unauthorized use of any Trademark, and all rights as a party in any opposition or similar proceedings including the right to sue for and recover all damages from any past or future infringements or other violations of the Trademarks.

2. The Assignor hereby undertakes at any time upon reasonable request to execute such documents and take such further actions as may be necessary to evidence the assignment of the Trademarks to the Assignee, and to enable the Assignee to obtain and maintain registrations for the Trademarks, all without further consideration but at the sole expense of the Assignee.

3. The Assignor acknowledges that the Assignee has been using the name "Property Brothers" in connection with the development, production and exploitation of a television series currently called "Property Brothers: Forever Home" prior to the date of this Agreement with the full knowledge and consent of the Assignor.
