**INTELLECTUAL PROPERTY CONTRIBUTION AND CONVEYANCE
AGREEMENT**

1. Contribution and Conveyance of Intellectual Property. Guardsman Ohio Corporation, an Ohio corporation ("*Guardsman Ohio*"), does hereby absolutely, irrevocable and unconditionally assign, transfer, contribute and convey to Guardsman US LLC, an Ohio limited liability company ("*Guardsman LLC*"), as a capital contribution without the issuance of additional membership interests of Guardsman LLC, all right title and interest in and to all copyrights, trademarks, patents, formulas, domain names, trade secrets and other intellectual property owned by Guardsman Ohio that is primarily or exclusively used in connection with the Guardsman North America business, including but not limited to the intellectual property listed on Exhibit A attached to this Intellectual Property Contribution and Conveyance Agreement, which is hereby incorporated herein as if fully set forth (the "*Intellectual Property*"), effective as of 10:53 p.m. on December 31, 2017. Guardsman Ohio and Guardsman LLC desire for this contribution to be afforded nonrecognition treatment for purposes of U.S. federal income tax under the Internal Revenue Code of 1986, as amended (the "Code"), Section 351, and the regulations promulgated thereunder.

2. Additional Transfer Documents. Guardsman Ohio shall execute and deliver to Guardsman LLC any and all other instruments which may be necessary to vest in Guardsman LLC the full right, title and interest in and to any of the Intellectual Property, and shall provide all reasonable assistance to Guardsman LLC as may be necessary or convenient for the orderly transfer to and commencement of operation of the Intellectual Property by Guardsman LLC.

3. Further Acts and Other Documents. Guardsman Ohio agrees to perform any further acts, and to execute any and all other documents, which are, in the opinion of Guardsman LLC or its counsel, necessary or appropriate to carry out the terms and conditions of this Agreement to the fullest extent Guardsman Ohio may do so without violating or being in default under any applicable law or under any other agreement to which any Guardsman Ohio is a party. Guardsman LLC agrees to perform any further acts, and to execute any and all other documents, instruments and notices which are necessary to carry out the terms and conditions of this Agreement to the fullest extent Guardsman LLC may do so without violating or being in default under any applicable law or under any other agreement to which Guardsman LLC is a party or to which any Guardsman Ohio in its capacity as a former owner of any of the Intellectual Property is a party. Guardsman Ohio hereby authorizes and requests that the Commissioners of Copyrights, Patents and Trademarks of the United States, and each sovereign official holding a corresponding position of authority in any country within which Guardsman Ohio has registered intellectual property or has pending one or more intellectual property applications relating to the Intellectual Property, to issue and to record the title of Guardsman LLC as owner of all right, title, and interest in and to the Intellectual Property registrations and applications including but not limited to those identified in Exhibit A,

together with all goodwill arising from the use of and symbolized by the Intellectual Property.

4. Representations and Warranties of Guardsman Ohio. Guardsman Ohio does hereby represent and warrant to and covenant with Guardsman LLC that Guardsman Ohio has full right and authority to enter into and perform its obligations under this Agreement and that the Intellectual Property has not been previously conveyed, sold or transferred.

5. Representations and Warranties of Guardsman LLC. By executing the Acceptance of this Agreement, Guardsman LLC represents and warrants to and covenants with Guardsman Ohio that Guardsman LLC will take any and all actions necessary or appropriate to effectuate the assignment of the Intellectual Property from Guardsman Ohio to Guardsman LLC.

6. Governing Law. This Agreement shall be construed and enforced in accordance with the laws of Delaware, without consideration of principles of conflicts or choice of laws.

7. Severability. Any provision of this Agreement that may be determined by competent authority to be prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions of this Agreement, and any such prohibition or unenforceability in such jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction.



This Agreement embodies the entire agreement between the parties with respect to the subject matter hereof and supersedes any prior contract, agreement or understanding, whether oral or in writing, which may have existed between the parties. This Agreement shall be binding upon all successors and assigns of the parties hereto.

This Agreement may be executed in one or more counterparts and in separate counterparts, each of which shall be deemed to be an original copy of this Agreement, and all of which, when taken together, shall be deemed to constitute one and the same agreement.
