**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 13, 2019 ("Release"), is made by Stellus Capital Investment Corporation, as Agent ("Agent") in favor of Mobileum, Inc., a Delaware corporation ("Grantor").

**WHEREAS**, pursuant to that certain Guarantee and Security Agreement dated as of November 1, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantor, Agent, and others party thereto, and the Trademark Security Agreement dated as of April 13, 2018 by and among the Grantor and Agent ("Trademark Security Agreement"), Grantor mortgaged, pledged and granted to Agent, for the benefit of the Secured Parties, a Lien on and security interest in, all of Grantor's right, title and interest in, to, and under all Trademark Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on April 18, 2018 at Reel 6343 Frame 0793.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Lien on and security interest in, all of Grantor's right, title and interest in, to, and under all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
