RELEASE OF COLLATERAL  
PATENT, TRADEMARK, COPYRIGHT  
AND LICENSE ASSIGNMENT

WHEREAS, Jason Incorporated (hereinafter referred to as "Jason"), a Delaware corporation having its principal place of business at 411 East Wisconsin Avenue, Milwaukee, Wisconsin and The First National Bank of Boston (hereinafter referred to as the "Bank"), having its principal place of business at 100 Federal Street, Boston, Massachusetts, are parties to that certain Collateral Patent, Trademark, Copyright and License Assignment dated as of January 8, 1986 (hereinafter referred to as the "Assignment"), pursuant to which Jason granted, conveyed and assigned to the Bank a security interest in all of Jason's right, title and interest in and to certain intellectual property, including without limitation the United States trademarks and trademark applications shown in the attached Exhibit A;

WHEREAS, the Assignment was recorded in the United States Patent and Trademark Office on May 20, 1986 on Reel 0534, Frame 088 through Frame 144;

WHEREAS, the Bank has agreed to release and reassign its entire right, title and interest, including goodwill, in and to the above-referenced trademarks and trademark applications;

NOW, THEREFORE, in consideration of and in exchange for the sum of one dollar (\$1.00) to it in hand paid by Jason and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Bank hereby releases all security interests, and reconveys and reassigns unto Jason its entire right, title and interest, including goodwill, in and to the above-referenced trademarks and trademark applications, including any rights of action and recovery for past infringement of said trademarks, and in, to and under any and all renewals and other extensions of said trademarks. Such reconveyance and reassignment is without recourse and without any warranty or representation whatsoever.

IN WITNESS WHEREOF, the Bank has caused this instrument to be executed by its duly authorized officers on this 27<sup>th</sup> day of October, 1989.
