**TERMINATION OF SECURITY INTEREST
TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST dated as of September 6, 2019 (this "Termination") is made by **MANUFACTURERS AND TRADERS TRUST COMPANY**, as Collateral Agent (together with its successors and assigns, the "Grantee") under that certain Grant of Security Interest dated April 24, 2014 (as amended, restated or otherwise modified from time to time, the "Grant") in favor of **NORTHSTAR DEMOLITION AND REMEDIATION, LP**, a Delaware limited partnership formerly known as NCM Demolition and Remediation, LP (the "Grantor").

WHEREAS, pursuant to the Grant, the Grantor granted a security interest to the Grantee, for the benefit of the Lenders, in all of the Grantor's right, title, and interest in and to the trademarks, trademark registrations, trademark applications and trademark licenses set forth on Schedule A attached hereto (the "Trademark Collateral");

WHEREAS, the Grant was recorded with the United States Patent and Trademark Office on April 24, 2014 at reel number 5267 and frame number 0806 and reel number 5267 and frame number 0793, respectively; and

WHEREAS, the Grantor has requested and the Grantee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, and discharge of its security interest in the Trademark Collateral (the "Released Collateral");



The Grantee consents and agrees to execute and deliver, at the request and cost of the Grantor, such further instruments, documents and release forms as the Grantor may reasonably request to more effectively release, terminate and discharge any such liens and security interests upon such Released Collateral.
