## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Release") is made and effective as of August 30, 2019 ("Effective Date") and is granted by **People's United Bank, National Association**, a national banking association organized under the laws of the United States of America ("People's") and **Velvac, Incorporated**, a Delaware corporation, a Delaware limited liability company ("Company").

WHEREAS, People's and Company entered into a Security Agreement dated April 3, 2017 (but effective as of April 1, 2017) (as amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which Company granted People's a continuing first priority security interest in, among other property, certain intellectual property of Company.

WHEREAS, in connection with the Security Agreement, Company executed and delivered to People's that certain Trademark Security Agreement dated April 3, 2017 (but effective as of April 1, 2017) (as amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement").

WHEREAS, pursuant to the Trademark Security Agreement, People's is the holder of a continuing first priority security interest in the Trademarks (as defined in the Trademark Security Agreement).

WHEREAS, Company has requested that People's execute this Release in order to effectuate, evidence and record the release, termination and reassignment to Company of any and all right, title and interest that People's may have in the Trademarks pursuant to the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, People's and Company agree as follows:

1. All initially capitalized terms used but not otherwise defined in this Release have the meanings given to them in the Trademark Security Agreement.
2. People's, on behalf of itself and its successors, legal representatives and assigns, hereby terminates the Trademark Security Agreement and forever unconditionally, expressly and irrevocably releases, terminates and discharges all security interests People's has pursuant to the Trademark Security Agreement in, to and under the Trademarks, including, without limitation, the trademarks and trademarks applications listed in **Schedule 1** hereto.
3. People's hereby authorizes and requests (a) the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Trademark Security Agreement and the Trademarks, including, without limitation, the trademarks and trademarks applications listed in **Schedule 1** hereto and (b) any other state, federal and/or foreign government agency to record this Release with regard to the Trademark Security Agreement and the Trademarks, including, without limitation, the trademarks and trademarks applications listed in **Schedule 1** hereto.


