**SECOND AMENDMENT  
TO  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Second Amendment to Intellectual Property Security Agreement is entered into as of July 22, 2019 (the "Amendment") by and between CITY NATIONAL BANK ("Bank") and LIFE LINE SCREENING HOLDINGS, LLC, a Delaware limited liability company ("Holdings"), and LIFE LINE SCREENING OF AMERICA LTD., an Ohio limited liability company and a wholly owned subsidiary of Holdings ("America"), and LIFE LINE COMMUNITY HEALTHCARE, LLC a Delaware limited liability company ("Community" and with America and Holdings, each, a "Grantor", and collectively, "Grantors").

**RECITALS**

Grantors and Bank are parties to that certain Intellectual Property Security Agreement dated as of August 29, 2014, as amended from time to time (the "IPSA"). America owns new trademark items. Bank and Grantors wish to update the IPSA to include the additional trademark items belonging to America.

The parties desire to amend the IPSA in accordance with the terms of this Amendment.

NOW, THEREFORE, the parties agree as follows:

1. Exhibit C (Trademarks) to the IPSA is hereby amended and replaced in its entirety with Exhibit C, attached hereto.
2. Unless otherwise defined, all initially capitalized terms in this Amendment shall be as defined in the IPSA. The IPSA, as amended hereby, shall be and remain in full force and effect in accordance with its respective terms and hereby is ratified and confirmed in all respects. Except as expressly set forth herein, the execution, delivery, and performance of this Amendment shall not operate as a waiver of, or as an amendment of, any right, power, or remedy of Bank under the IPSA, as in effect prior to the date hereof. Each Grantor ratifies and reaffirms the continuing effectiveness of all agreements entered into in connection with the IPSA.
3. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one instrument.
