RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made as of September 6, 2019 by Citizens Bank, N.A. (formerly known as RBS Citizens, N.A.), acting in its capacity as Administrative Agent for certain lenders (in such capacity, the “**Secured Party**”), in favor of API INDUSTRIES, INC., a Delaware corporation (the “**Grantor**”).

WHEREAS, the Grantor granted a security interest (the “**Security Interest**”) in certain trademarks to the Secured Party, as set forth in that certain Grant of Security Interest (Trademarks) dated as of September 30, 2013 by the Grantor in favor of the Secured Party, which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on October 2, 2013, at Reel 005123 and Frame 0499 (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the “**Trademark Security Agreement**”)(capitalized terms used herein, and not otherwise defined herein, shall have the meanings as set forth in the Trademark Security Agreement);

WHEREAS, the Grantor granted a Security Interest in certain patents to the Secured Party, as set forth in that certain Grant of Security Interest (Patents) dated as of September 30, 2013 by the Grantor in favor of the Secured Party, which was recorded with the USPTO on October 2, 2013, at Reel 031333 and Frame 0029 (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the “**Patent Security Agreement**”)(capitalized terms used herein, and not otherwise defined herein, shall have the meanings as set forth in the Trademark Security Agreement and Patent Security Agreement, as applicable);

WHEREAS, the Grantor fulfilled its obligations to the Secured Party pursuant to that certain payoff letter between the Grantor and the Secured Party dated on or about September 5, 2019 (the “**Payoff Letter**”); and

WHEREAS, the Secured Party desires to release the Security Interest granted to the Secured Party (i) in the Trademarks and the Collateral as set forth in the Trademark Security Agreement, including those trademarks identified in Exhibit A attached hereto, and (ii) in the Patents and the Collateral as set forth in the Patent Security Agreement, including those patents identified in Exhibit B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Pursuant to the terms and conditions of the Payoff Letter, the Secured Party hereby terminates and releases the Security Interest granted by the Grantor to the Secured Party as set forth in the Trademark Security Agreement and fully discharges the Secured Party’s Security Interest in the Trademarks and the Collateral, including the trademarks identified in Exhibit A and all products and proceeds of and rights associated with the foregoing;
2. Pursuant to the terms and conditions of the Payoff Letter, the Secured Party hereby terminates and releases the Security Interest granted by the Grantor to the Secured Party as set forth in the Patent Security Agreement and fully discharges the Secured Party’s Security

Interest in the Patents and the Collateral, including the patents identified in Exhibit B and all products and proceeds of and rights associated with the foregoing; and

3. The Secured Party hereby authorizes and requests that the USPTO notes and records the existence of the releases hereby given.
