**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL ("Termination") is made effective as of September 4, 2019 (the "Effective Date") by Multiplier Capital II, LP, a Delaware limited partnership (the "Releasing Party") in favor of New Form Digital, LLC, a Delaware limited liability company and each of the entities listed on Exhibit A to the IP Security Agreement (defined herein) (collectively, the "Grantors" and each, individually, a "Grantor").

WHEREAS, pursuant to the Loan and Security Agreement dated as of May 3, 2018 (as amended from time to time, "Loan Agreement") to which the Releasing Party and Grantors are parties, and the Intellectual Property Security Agreement entered into as of April 8, 2019 ("IP Security Agreement"; capitalized terms used herein without definition have the meaning assigned in the Loan Agreement or IP Security Agreement, as applicable) by and between the Releasing Party and the Grantors and recorded in the United States Patent and Trademark Office on April 15, 2019 at Reel/Frame 6618/0318, the Grantors granted to the Releasing Party a security interest in all of each Grantor right, title and interest in the Intellectual Property and IP Collateral, including the intellectual property listed on Schedule A (collectively, the "Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Releasing Party hereby terminates the IP Security Agreement, terminates, releases, discharges and disclaims, any lien, security interest, pledge and/or assignment created in its favor in the Collateral, and releases all of the Releasing Party's right, title and interest in the Collateral.
