RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of September 3, 2019 is made by Jefferies Finance, LLC, in its capacity as collateral agent pursuant to the Security Agreement (in such capacity, the “Agent”), in favor of MediciGroup, Inc., a Pennsylvania corporation and Access to Patients, LLC, a Pennsylvania limited liability company (individually, a “Grantor”, and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors are party to a Second Lien Security Agreement, dated as of October 20, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), in favor of the Agent;

WHEREAS, in connection with the Security Agreement, the Grantors executed and delivered the Second Lien Trademark Security Agreement, dated as of October 20, 2016, in favor of the Agent (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor pledged and granted to the Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral (excluding any Excluded Assets) of such Grantor: Trademarks of such Grantor set forth on Schedule I attached hereto (the “Released Trademarks”);

WHEREAS, the Agent recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the “USPTO”) on October 21, 2016, at Reel/Frame No. 5905/0357; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Grantors, as follows:

SECTION 1. Definitions. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Grantors’ right, title and interest in, to and under the Released Trademarks; and all right, title and interest of the Agent in the Released Trademarks hereby ceases and becomes void.

SECTION 3. Further Assurances. The Agent hereby authorizes the Grantors or the Grantors’ authorized representatives to (i) record this Release with the USPTO and/or (ii) otherwise record or file this Release in the applicable governmental office or agency. The

Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments, and do any and all further acts which the Grantors (or their agents or designees) reasonably request (at the Grantors' sole cost and expense) in order to confirm this Release and the Grantors' right, title and interest in, to and under the Released Trademarks.

SECTION 4. Choice of Law. This Release and any claim, controversy or dispute arising under or related to this Release, whether in tort, contract (at law or in equity) or otherwise, shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.

SECTION 5. Counterparts. This Release may be executed in any number of counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. Delivery of an executed counterpart to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually signed original.
