INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT

This Intellectual Property Assignment and Assumption Agreement (this "**IP Assignment Agreement**"), is made and entered into effective as of July 31, 2019 ("**Closing Date**"), by and among The C.F. Sauer Company, a Virginia corporation ("**Sauer**"), The Spice Hunter, Inc., a California corporation ("**Spice Hunter**"), CFS West Holdings, Inc., a Kansas corporation ("**CFSW**"), Hardesty Candy Company, a Virginia corporation ("**Hardesty**"), and together with Sauer, Spice Hunter and CFSW, "**Assignors**"), and Sauer Brands, Inc., a Delaware corporation ("**Assignee**"). Capitalized terms used but not otherwise defined herein shall have the respective meanings set forth in that certain Asset Purchase Agreement dated as of May 17, 2019 to which Assignors and Assignee are party ("**Purchase Agreement**").

WHEREAS, pursuant to the Purchase Agreement, Assignors have agreed to sell, assign, convey, transfer and deliver to Assignee, and Assignee has agreed to purchase and acquire from Assignors, all of each Assignor's right, title and interest in and to the Purchased Assets, including, without limitation, the Intellectual Property Assets identified in Schedule A and all other Intellectual Property Assets; and

NOW THEREFORE, in consideration of the foregoing and the representations, warranties and agreements herein set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor and Assignee, intending to be legally bound, hereby agree as follows:

1. **Assignment of Intellectual Property.** Upon the terms set forth in the Purchase Agreement, each Assignor hereby sells, assigns, conveys, transfers and delivers to Assignee, and Assignee hereby purchases and acquires from such Assignor, free and clear of all Encumbrances, all of such Assignor's right, title and interest in and to the Seller Intellectual Property, including without limitation any and all income royalties, or payments due or payable to such Assignor as of the Closing Date or thereafter as well as the right to sue for any and all past, present and future infringements of such Intellectual Property, and to receive any and all damages awarded as a result of any such claim, and all other rights and interests therein and thereto ("**Assigned IP**"). In order to enable the use by Assignee of the website names and addresses included in the Purchased Assets ("**Domain Names**"), including, without limitation, those set forth on Schedule A hereto, each Assignor agrees to provide Assignee, on the Closing Date, with any account information with any Person with whom the Domain Names are registered, if any, including any user names and passwords of such Assignor relating thereto.

2. **Further Assurances.**

(a) Each Assignor hereby covenants and agrees that it shall, at any time after the Closing Date or from time to time thereafter at the reasonable request of Assignee, (i) execute and deliver such further instruments of sale, assignment, conveyance, transfer and delivery to Assignee as shall be reasonably necessary or appropriate to vest in Assignee good and indefeasible title to the Assigned IP, to otherwise establish the record of Assignee's title thereto, or to more effectively consummate the assignments contemplated hereby, and (ii) assist Assignee, at Assignee's request and at Assignee's sole cost and expense, in exercising any rights with respect thereto.

(b) Each Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, the United States Copyright Office, and the applicable officials of any other agencies or authorities, governmental or otherwise, to issue or transfer all of the Assigned IP to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.

(c) As and to the extent that any governmental or quasi-governmental office or agency pertaining to the filing, registration, application or processing of intellectual property, including without limitation the United States Patent and Trademark Office, the United States Copyright Office, or the

offices in which any of the Assigned IP listed in Schedule A is or was registered, applied for, pending or recorded, requests that additional forms or documents be presented or executed by any Assignor or its agents, affiliates or attorneys, each Assignor agrees to execute such documents and deliver them to Assignee or its agents, attorneys or designees, as applicable.

3. **Successors and Assigns.** The terms and provisions of this IP Assignment Agreement shall be binding upon, and inure to the benefit of, Assignors and Assignee, and each of their respective successors and assigns.

4. **Third Party Beneficiaries.** Nothing in this IP Assignment Agreement is intended to or shall confer upon any Person other than the parties and their respective successors and assigns, any rights, benefits, or remedies of any nature whatsoever under or by reason of this IP Assignment Agreement or any transaction contemplated by this IP Assignment Agreement.

5. **Choice of Law.** This IP Assignment Agreement and the rights and obligations of the parties shall be governed by and shall be enforced and interpreted in accordance with the laws of the Commonwealth of Virginia, without regard to conflicts of law doctrines.

6. **Terms of the Purchase Agreement.** The terms of the Purchase Agreement, including, but not limited to, Assignors' representations, warranties, covenants, agreements and indemnities relating to the Seller Intellectual Property, are incorporated herein by reference. Each Assignor and Assignee acknowledges and agrees that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby, but shall remain in full force and effect to the extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms and provisions of the Purchase Agreement shall govern.

7. **Counterparts.** This IP Assignment Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Copies (facsimile, electronic or original) of signatures to this IP Assignment Agreement shall be deemed to be originals and shall be binding to the same extent as original signatures.
