**TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated effective as June 26, 2019, is made by KeyBank National Association, ("Secured Party"), in favor of Wildcatch, LLC (the "Pledgor") as follows:

C. WHEREAS, the Borrower and Pledgor have requested that the Secured Party release its Lien on and continuing security interest in, all right, title and interest of the Secured Party in and to the Collateral.


