5. Assignor shall ensure that the Transferred Trademark is a valid Trademark and that no third party owns the Trademarks


6. After the transfer of the trademark right, Assignee's authority:

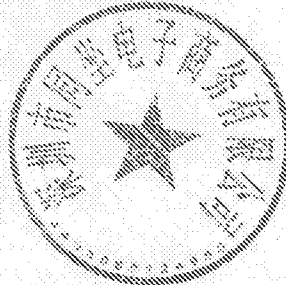


