RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest ("Release") is made effective as of June 11, 2019 by ORIX Growth Capital, LLC (f/k/a ORIX Ventures, LLC), (the "Lender") to Afiniti, Inc. (f/k/a SATMAP Incorporated), a Delaware corporation (the "Grantor"), as follows:

WHEREAS, said IP Security Agreements were recorded in the United States Patent & Trademark Office

(b) on March 10, 2017, at reel/frame 006009/0853; and



1. Release of Security Interest. The Lender terminates, releases and discharges its security interest in and to the Trademarks, and reassigns to the Grantor any and all right, title and interest it may have in and to the Trademarks, without recourse to the Grantor.
