## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

September 16, 2019

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”), is dated effective as of July 1, 2019, made by **CRG SERVICING LLC** (the “Grantee”), and acknowledged and agreed by **SLOAN PHARMA S.À R.L.**, a private limited liability company (“société à responsabilité limitée”) governed by the laws of the Grand Duchy of Luxembourg, registered with the Luxembourg Trade and Companies Register under the number B191903 (the “Grantor”).

WHEREAS, pursuant to (i) that certain Security Agreement dated as of July 15, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, certain Guarantors party thereto and the Grantee and (ii) that certain Patent and Trademark Security Agreement dated as of July 15, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”) made by the Grantor in favor of the Grantee, a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, pursuant to the terms of the Security Agreement, the IP Security Agreement was recorded at the United States Patent and Trademark Office on July 15, 2016 at Reel 5835/Frames 0273-0282; and

WHEREAS, Grantee now desires to totally and permanently terminate, release, discharge and disclaim its security interest and any other interest it may have in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Grantee hereby agrees and states as follows:

1. Definitions. The term “Trademarks,” as used herein, shall mean all right, title and interest of every kind and nature in the trademarks, trademark registrations and trademark applications listed on Exhibit A hereto.
2. Release of Security Interest. Grantee hereby totally and permanently terminates, releases, discharges and disclaims its security interest in the Trademarks.
3. Disclaimer of Any Other Interest. Grantee hereby totally and permanently terminates, releases, discharges and disclaims all other right, title and interest (if any) it may have in the Trademarks.




