AMENDED AND RESTATED

INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Agreement") is made as of the 22<sup>nd</sup> day of August, 2019, by CHICKEN SOUP FOR THE SOUL ENTERTAINMENT INC., a Delaware corporation, having an address at 132 East Putnam Avenue, Cos Cob, Connecticut 06807 ("CSSE"), SCREEN MEDIA VENTURES, LLC, a Delaware limited liability company, having an address at 800 Third Avenue, 3<sup>rd</sup> Floor, New York, New York 10022 ("SMV" and together with CSSE, collectively, the "Borrower"), jointly and severally, BD PRODUCTIONS, LLC, a Connecticut limited liability company, having an address at c/o Chicken Soup for the Soul Entertainment Inc., 132 East Putnam Avenue, Cos Cob, Connecticut 06807 ("BD Productions"), 757 FILM ACQUISITION LLC, a Delaware limited liability company, having an address at c/o Screen Media Ventures, LLC, 800 Third Avenue, 3<sup>rd</sup> Floor, New York, New York 10022 ("757 Film Acquisition"), SCREEN MEDIA FILMS, LLC, a Delaware limited liability company, having an address at c/o Screen Media Ventures, LLC, 800 Third Avenue, 3<sup>rd</sup> Floor, New York, New York 10022 ("Screen Media"), PIVOTSHARE, INC., a Delaware corporation, having an address of 132 E. Putnam Avenue, Cos Cob, Connecticut 06807 ("Pivotshare"), A SHARP INC., a Delaware corporation, having an address of 132 E. Putnam Avenue, Cos Cob, Connecticut 06807 ("A Sharp"), and CRACKLE PLUS, LLC, a Delaware limited liability company, having an address of 132 E. Putnam Avenue, Cos Cob, Connecticut 06807 ("Crackle Plus" and together with BD Productions, 757 Film Acquisition, Screen Media, Pivotshare and A Sharp, collectively, the "Guarantor"; the Guarantor, together with the Borrower, is referred to herein, individually and collectively, as the "Grantor"), jointly and severally, in favor of PATRIOT BANK, N.A., having an address at 900 Bedford Street, Stamford, Connecticut 06901 (the "Lender") and is in consideration of the mutual covenants contained herein and benefits to be derived herefrom.

WITNESSETH:

WHEREAS, reference is made to that certain Amended and Restated Loan and Security Agreement, dated as of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among Grantor and Lender, pursuant to which Lender, subject to the terms and conditions contained therein, agreed to make a \$16,000,000 term loan (the "Loan"), otherwise to extend credit and/or provide financial accommodations to Borrower; and

WHEREAS, reference is made to that certain Second Amended and Restated Guaranty Agreement, dated as of the date hereof, made by Guarantor in favor of Lender (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Guaranty"), pursuant to which Guarantor guaranteed the Guaranteed Obligations (in each case where used herein, as defined in the Guaranty), which include the Obligations; and

WHEREAS, pursuant to Loan Agreement, Grantor has granted to Lender a security interest in and to the Collateral, as security for the Obligations and the Guaranteed Obligations; and

WHEREAS, the obligation of Lender to make the Loan is conditioned upon, among other things, the execution and delivery by Grantor of an agreement in the form hereof, pursuant to which Grantor confirms its grant of security interest provided in the Loan Agreement and further grants to Lender a security interest in and to the IP Collateral (as defined herein).

NOW, THEREFORE, in consideration of the mutual conditions and agreements set forth in this Agreement, and for good and valuable consideration, the receipt of which is hereby acknowledged, Grantor and Lender hereby agree as follows:

SECTION 1. Definitions.

1.1 Generally. All references herein to the "UCC" shall mean the Uniform Commercial Code as in effect in the State of Connecticut or, when the laws of any other jurisdiction govern the perfection or enforcement of any Lien, the Uniform Commercial Code of such jurisdiction.

1.2 Definition of Certain Terms Used Herein. Unless the context otherwise requires, all capitalized terms used but not defined herein shall have the meanings set forth in the Loan Agreement. In addition, as used herein, the following terms shall have the following meanings:

"Copyright" or "Copyrights" shall mean all copyrights and like protections in each work of authorship or derivative work thereof of Grantor or in which Grantor has any right, title or interest now or in the future (including, without limitation, all copyrights and like protections of other Persons), whether registered or unregistered and whether published or unpublished, including, without limitation, the United States copyright registrations and copyright applications listed on Exhibit A, annexed hereto and made a part hereof, together with any goodwill of the business connected with, and symbolized by, any of the foregoing.

"Copyright Licenses" shall mean all agreements, whether written or oral, providing for the grant by or to Grantor of any right under any Copyright, including, without limitation, the agreements listed on Exhibit A, annexed hereto and made a part hereof.

"Copyright Office" shall mean the United States Copyright Office or any other federal governmental agency which may hereafter perform its functions.

"Domain Names" shall mean all domain names and domain name registration applications, that are owned by Grantor or in which Grantor has any right, title or interest, now or in the future (including, without limitation, the domain names and domain name registration applications of other Persons), including but not limited to all derivatives or variations, whether authorized or unauthorized, including those listed on Exhibit D annexed hereto and made a part hereof, together with any Trademarks or goodwill of the business connected with, and symbolized by, any of the foregoing.

"Domain Name Licenses" shall mean all agreements, whether written or oral, providing for the grant by or to Grantor of any right under any Domain Name or any Domain Name Rights, including, without limitation, the agreements listed on Exhibit D, annexed hereto and made a part hereof.

"Domain Name Registry" means, any domain name registry with whom the Domain Names are registered, including, without limitation, the Internet Corporation for Assigned Names and Numbers.

"Domain Name Rights" shall mean any and all past, present or future rights in, to and associated with any Domain Names and/or Domain Name Licenses throughout the world, whether arising under federal law, state law, common law, foreign law, or otherwise. Such interest and

right shall be held to the full extent of the term for which the Domain Names or any registration, renewal or extension thereof is or may be granted to the extent permitted by law.

“Intellectual Property” shall have the meaning assigned to such term in SECTION 3 of this Agreement.

“IP Collateral” shall have the meaning assigned to such term in SECTION 2 of this Agreement.

“Lender” shall have the meaning assigned to such term in the preamble of this Agreement

“Licenses” shall mean, collectively, the Copyright Licenses, the Patent Licenses, the Trademark Licenses, the Domain Name Licenses and any other license providing for the grant by or to Grantor of any right under any Intellectual Property.

“Loan Agreement” shall have the meaning assigned to such term in the first whereas clause of this Agreement.

“Patents” shall mean all patents and applications for patents of Grantor or in which Grantor has any right, title or interest, now or in the future (including, without limitation, the patents and applications for patents of other Persons), and the inventions and improvements therein disclosed, and any and all divisions, revisions, reissues and continuations, continuations-in-part, extensions, and reexaminations of said patents including, without limitation, the United States patent registrations and patent applications listed on Exhibit B, annexed hereto and made a part hereof.

“Patent Licenses” shall mean all agreements, whether written or oral, providing for the grant by or to Grantor of any right under any Patent, including, without limitation, the agreements listed on Exhibit B, annexed hereto and made a part hereof.

“PTO” shall mean the United States Patent and Trademark Office or any other federal governmental agency which may hereafter perform its functions.

“Trademark” or “Trademarks” shall mean all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade dress, trade styles, service marks, designs, logos and other source or business identifiers of Grantor or in which Grantor has any right, title or interest, now or in the future (including, without limitation, any of the foregoing of other Persons), whether registered or unregistered, including, without limitation, the United States trademark registrations and trademark applications listed on Exhibit C, annexed hereto and made a part hereof, together with any goodwill of the business connected with, and symbolized by, any of the foregoing.

“Trademark Licenses” shall mean all agreements, whether written or oral, providing for the grant by or to Grantor of any right under any Trademark, including, without limitation, the agreements listed on Exhibit C, annexed hereto and made a part hereof.

SECTION 2. Grant of Security Interest; Assignment of Domain Names. In furtherance and as confirmation of the security interest granted by Grantor to Lender under the Loan Agreement and as further security for the prompt payment and performance of all Obligations and all Guaranteed Obligations, Grantor hereby ratifies such security interest and grants to Lender a continuing security interest in and Lien upon all of the present and future right, title and interest of Grantor in and to the following property, and each item thereof, whether now owned or existing or

hereafter acquired or arising, together with all additions to, accessions to, improvements to, substitutions for, and all replacements, products, and cash and non-cash proceeds of the following property, including proceeds of and unearned premiums with respect to insurance policies, and claims against any Person for loss, damage or destruction of any of the following property (collectively, the "IP Collateral"):

- (a) All Copyrights and Copyright Licenses;
- (b) All Patents and Patent Licenses;
- (c) All Trademarks and Trademark Licenses;
- (d) All Domain Names, Domain Name Licenses and Domain Name Rights;
- (e) All other Licenses;
- (f) All renewals of any of the foregoing;
- (g) All trade secrets, know-how and other proprietary information; works of authorship and other copyright works (including copyrights for computer programs), and all tangible and intangible property embodying the foregoing; inventions (whether or not patentable) and all improvements thereto; industrial design applications and registered industrial designs; books, records, writings, computer tapes or disks, flow diagrams, specification sheets, computer software, source codes, object codes, executable code, data, databases, and other physical manifestations, embodiments or incorporations of any of the foregoing, and any Licenses in any of the foregoing, and all other Intellectual Property and proprietary rights;
- (h) All general intangibles (as defined in the UCC) connected with the use of, or related to, any and all Intellectual Property (including, without limitation, all goodwill of Grantor and its business, products and services appurtenant to, associated with, or symbolized by, any and all Intellectual Property and the use thereof);
- (i) All accounts, accounts receivable, fees, income, royalties, damages and payments now and hereafter existing, arising, due and/or payable under and with respect to any of the foregoing, including, without limitation, payments under all Licenses entered into in connection therewith and damages and payments for past or future infringements, misappropriations or dilutions thereof;
- (j) All claims, causes of action and the right to sue (including, without limitation, all rights to and claims for damages, restitution and injunctive or other legal and equitable relief) for past, present and future infringements, misappropriations, violations, breaches, defaults, misuses and dilutions of any of the foregoing; and
- (k) All of Grantor's rights corresponding to any of the foregoing throughout the world.

In addition to, and not by way of limitation of, the grant of the security interest in and to the Domain Names, the Domain Name Licenses and the Domain Name Rights above, Grantor hereby irrevocably grants, assigns, transfers, conveys and sets over to Lender, Grantor's entire right, title and interest in and to the Domain Names, the Domain Name Licenses and the Domain

Name Rights; provided that such grant, assignment, transfer, conveyance and set over shall be and become of force and effect only upon or after the occurrence and during the continuance of an Event of Default. To effectuate such grant, assignment, transfer, conveyance and set over, Grantor has executed in blank and delivered to Lender an assignment of domain names and domain name rights in substantially the form of Exhibit D-1 hereto for each Grantor (collectively, the "Assignment of Domain Names"). Grantor hereby authorizes Lender to complete as assignee and record the Assignment of Domain Names, or take other appropriate steps to transfer effective ownership and control of the Domain Names, the Domain Name Licenses, and the Domain Name Rights, with the respective Domain Name Registry upon the occurrence and during the continuance of an Event of Default and/or the exercise of Lender's remedies under this Agreement and/or the Loan Documents. Grantor also hereby (i) covenants and agrees to provide Lender with an updated annex for the Assignment of Domain Names within five (5) days of Lender's request therefor, and (ii) authorizes Lender to update the annex to the Assignment of Domain Names, and attach a new annex to the Assignment of Domain Names, concurrently with the delivery of each update to Exhibit D provided by Grantor hereunder and prior to completing as assignee and recording the Assignment of Domain Names.

SECTION 3. Protection of Intellectual Property by Grantor. Grantor shall undertake the following with respect to each of the items respectively described in Sections 2(a), (b), (c), (d), (e), (f), (g) and (h) (collectively, the "Intellectual Property"):

(a) Pay all renewal fees and other fees and costs associated with maintaining the Intellectual Property and with the processing and prosecution of the Intellectual Property and take all other steps reasonably necessary to maintain each registration of the Intellectual Property.

(b) Take all actions reasonably necessary to prevent any of the Intellectual Property from becoming forfeited, abandoned, dedicated to the public, invalidated or impaired in any way.

(c) At Grantor's sole cost, expense, and risk, pursue the processing and prosecution of each application for registration which is the subject of the security interest created herein and not abandon or delay any such efforts.

(d) At Grantor's sole cost, expense, and risk, take any and all action which Grantor reasonably deems necessary or desirable under the circumstances to protect the Intellectual Property from infringement, misappropriation or dilution, including, without limitation, the prosecution and defense of infringement actions.

(e) Preserve and maintain all rights of Grantor in and to the Intellectual Property.

SECTION 4. Grantor's Representations, Warranties and Covenants. In addition to any representations, warranties and covenants contained in any of the other Loan Documents, Grantor represents, warrants and covenants that:

(a) Exhibit A is a true, correct and complete list of all United States Copyrights owned by Grantor and all Copyright Licenses to which Grantor is a party as of the date hereof.



(b) Exhibit B is a true, correct and complete list of all United States Patents owned by Grantor and all Patent Licenses to which Grantor is a party as of the date hereof.

(c) Exhibit C is a true, correct and complete list of all United States Trademarks owned by Grantor and all Trademark Licenses to which Grantor is a party as of the date hereof.

(d) Exhibit D is a true, correct and complete list of all Domain Names owned by Grantor and all Domain Name Licenses to which Grantor is a party as of the date hereof.

(e) Except as set forth in Exhibits A, B, C, and D, none of the Intellectual Property owned by Grantor is the subject of any licensing or franchise agreement pursuant to which Grantor is the licensor or franchisor as of the date hereof.

(f) All IP Collateral owned by Grantor is, and shall remain, free and clear of all Liens, encumbrances, and/or security interests in favor of any Person, other than Permitted Liens.

(g) Grantor shall not assign, transfer or otherwise alienate any IP Collateral, except for transfers to another Grantor as expressly permitted by, and in compliance with, Section 8.18 of the Loan Agreement, and, prior to effectuating any such transfer (i) delivering to Lender an updated Exhibit A, B, C and/or D to this Agreement, and (ii) executing such documents and making such filings and/or other recordings as Lender may request; provided, however, that notwithstanding the foregoing, in accordance with Section 8.18 of the Loan Agreement, Grantor may, in the ordinary course of its business and for value, without the consent of Lender, grant licensing or distribution rights with respect to any video content constituting IP Collateral for the purposes of dissemination or exhibition of such video content by Grantor or any third party, other than and excluding, in each case, the Specified Non-Guarantor Subsidiaries.

(h) Grantor owns, or is licensed to use, all Intellectual Property reasonably necessary for the conduct of its business as currently conducted. No claim has been asserted and is pending by any Person challenging or questioning the use by Grantor of any of its Intellectual Property, or the validity or effectiveness of any of its Intellectual Property. The use by Grantor of the Intellectual Property does not infringe upon the rights of any Person in any material respect. No holding, decision or judgment has been rendered by any Governmental Authority which would limit, cancel or question the validity of, or Grantor's rights in, any Intellectual Property in any respect.

(i) Grantor shall give Lender prompt written notice, with reasonable detail, following the occurrence of any of the following:

(i) Grantor's obtaining rights to, and filing applications for registration of, any new Intellectual Property, or otherwise acquiring ownership of any registered Intellectual Property (other than the acquisition by Grantor of the right to sell products containing the trademarks of others in the ordinary course of Grantor's business).

(ii) Grantor's becoming entitled to the benefit of any registered Intellectual Property whether as licensee or licensor (other than (A) commercially

available off the shelf computer programs, products or applications and (B) Grantor's right to sell products containing the trademarks of others in the ordinary course of Grantor's business).

(iii) Grantor's entering into any new Licenses with respect to the Intellectual Property (other than (A) commercially available off the shelf computer programs, products or applications and (B) Grantor's right to sell products containing the trademarks of others in the ordinary course of Grantor's business).

(iv) Grantor's knowing, or having reason to know, that any application or registration relating to any Intellectual Property may, other than as provided in SECTION 3 above, become forfeited, abandoned or dedicated to the public, or of any adverse determination or development (including, without limitation, the institution of, or any such determination or development in, any proceeding in the PTO, the Copyright Office, any Domain Name Registry or any court or tribunal) regarding Grantor's ownership of, or the validity or enforceability of, any Intellectual Property or Grantor's right to register the same or to own and maintain the same.

#### SECTION 5. Agreement Applies to Future Intellectual Property.

(a) The provisions of this Agreement shall automatically apply to any such additional property or rights described in subsections (i), (ii), (iii), and (iv) of SECTION 4(i), above, all of which shall be deemed to be and treated as "Intellectual Property" and "IP Collateral" within the meaning of this Agreement, it being acknowledged and agreed that the parentheticals providing circumstances under which Grantor is not required to give Lender notice under SECTION 4(i) above shall not in any way limit or diminish the automatic application of this Agreement to, and the inclusion of such property or rights in the definitions of, the Intellectual Property and IP Collateral. Upon the acquisition by Grantor of any additional Intellectual Property, Grantor shall promptly deliver to Lender an updated Exhibit A, B, C and/or D (as applicable) to this Agreement and hereby authorizes Lender to file, at Grantor's expense, such updated Exhibit as set forth in SECTION 5(b).

(b) Grantor shall execute and deliver, and have recorded, any and all agreements, instruments, documents and papers as Lender may reasonably request to evidence Lender's security interest in any IP Collateral (including, without limitation, filings with the PTO, the Copyright Office, any Domain Name Registry or any similar office or registry), and Grantor hereby authorizes Lender and appoints Lender as its attorney-in-fact to execute, file and record all such writings for the foregoing purposes, all such acts of such attorney being hereby ratified and confirmed; provided, however, that Lender's taking of such action shall not be a condition to the creation or perfection of the security interest created hereby.

SECTION 6. Grantor's Rights to Enforce Intellectual Property. Prior to the occurrence of an Event of Default, Grantor shall have the exclusive right to sue for past, present and future infringement of the Intellectual Property, including the right to seek injunctions and/or money damages in an effort by Grantor to protect the Intellectual Property against encroachment by third parties, provided, however, that:

(a) Grantor provides Lender with written notice of Grantor's institution of any legal proceedings to enforce its rights in any Intellectual Property.

(b) Any money damages awarded or received by Grantor on account of such suit (or the threat of such suit) shall constitute IP Collateral.

(c) Upon the occurrence and during the continuance of any Event of Default, Lender, by notice to Grantor, Lender may terminate or limit Grantor's rights under this SECTION 6.

SECTION 7. Lender's Actions to Protect Intellectual Property. In the event of:

(a) Grantor's failure to observe or perform any of Grantor's covenants, agreements or other obligations hereunder and such failure continues for ten (10) days after the earlier of Grantor's knowledge of a breach of any such covenant, agreement or other obligation or Grantor's receipt of notice from Lender of any such breach; and/or

(b) the occurrence and continuance of any other Event of Default,

Lender, acting in its own name or in that of Grantor, may (but shall not be required to) act in Grantor's place and stead and/or in Lender's own right with respect to the IP Collateral.

SECTION 8. Rights Upon Default. Upon the occurrence and during the continuance of an Event of Default, in addition to all other rights and remedies of Lender under the other Loan Documents and at law and in equity, Lender may exercise all rights and remedies of a secured party under the UCC with respect to the IP Collateral, in addition to which Lender may sell, license, assign, transfer, or otherwise dispose of the IP Collateral. Any person may conclusively rely upon a written notice from Lender that an Event of Default has occurred, and that Lender is authorized to exercise such rights and remedies.

SECTION 9. Lender as Attorney-in-Fact; Directive to Other Persons.

(a) Grantor hereby irrevocably makes, constitutes and appoints Lender (and all officers, employees or agents designated by Lender) as and for Grantor's true and lawful agent and attorney-in-fact, and in such capacity Lender shall have the right, with power of substitution for Grantor and in Grantor's name or otherwise, for the use and benefit of Lender:

(i) To supplement and amend from time to time Exhibits A, B, C and D of this Agreement and the annex to the Assignment of Domain Names to include any newly developed, applied for, registered, or acquired Intellectual Property of Grantor and any intent-to-use Trademark applications for which a statement of use or an amendment to allege use has been filed and accepted by the PTO.

(ii) Following the occurrence and during the continuance of any Event of Default, to exercise any of the rights, remedies and powers referenced herein.

(iii) Following the occurrence and during the continuance of any Event of Default, to execute all such instruments, documents, and papers, and to take such actions, as Lender determines to be necessary or desirable in connection with the exercise of such rights, remedies and powers and to cause the sale, license, assignment, transfer, or other disposition of the IP Collateral.

(iv) To preserve and protect all IP Collateral and Lender's Lien thereon.

(v) Following the occurrence and during the continuance of an Event of Default, to maintain the IP Collateral, enjoy all benefits of the IP Collateral, and otherwise exercise any rights and/or privileges of Grantor with respect to the IP Collateral, and take any actions that Grantor could take with respect to the IP Collateral, in each case as if Lender was the owner thereof.

(b) The power of attorney granted herein, being coupled with an interest, shall be irrevocable until this Agreement is terminated in writing by a duly authorized officer of Lender.

(c) Lender shall not be obligated to do any of the acts or to exercise any of the rights, remedies and powers authorized by SECTION 9(a), but if Lender elects to do any such act or to exercise any of such rights, remedies and powers, it shall not be accountable for more than it actually receives as a result of such exercise of rights, remedies and powers, and shall not be responsible to Grantor for any act or omission to act, except where a court of competent jurisdiction determines by final and non-appealable judgment that the subject act or omission to act has resulted from the gross negligence or willful misconduct of Lender.

(d) Grantor hereby irrevocably directs all Persons, upon the receipt from Lender of written notice to the effect that an Event of Default has occurred and is continuing, to (i) recognize Lender as the owner or contracting party with respect to the IP Collateral for any and all purposes as fully as it would recognize or accept Grantor as such owner or contracting party and continue performance of such Person's covenants and obligations in favor of Lender; provided, that nothing in this Agreement shall obligate Lender to perform any of Grantor's covenants or obligations with respect to the IP Collateral unless Lender agrees to assume such covenants or obligations in writing. A written notice from Lender stating that an Event of Default shall have occurred and be continuing and that Lender has succeeded to all of Grantor's rights with respect to the applicable IP Collateral shall be sufficient notice to all Persons of such circumstances without the necessity for any consent by Grantor. Grantor hereby waives any claim whatsoever against any Person for any action taken by such Person at the written request of Lender pursuant to the terms of this Agreement.

SECTION 10. Lender's Rights. Any use by Lender of the Intellectual Property, as authorized hereunder in connection with the exercise of Lender's rights, remedies and powers under this Agreement and the Loan Agreement shall be coextensive with Grantor's rights thereunder and with respect thereto and without any liability for royalties or other related charges.

SECTION 11. Intent. This Agreement is being executed and delivered by Grantor for the purpose of registering and confirming the grant of the security interest in the Collateral to Lender in the IP Collateral with the PTO, the Copyright Office and each Domain Name Registry. It is intended that the security interest granted pursuant to this Agreement is granted as a supplement to, and not in limitation of, the security interest granted to Lender under the Loan Agreement. All provisions of the Loan Agreement (including, without limitation, the rights, remedies, powers, privileges and discretions of Lender thereunder) shall apply to the IP Collateral. In the event of a conflict between this Agreement and Loan Agreement, the terms of this Agreement shall control

with respect to the IP Collateral and the terms of the Loan Agreement shall control with respect to all other Collateral.

SECTION 12. Further Assurances. Grantor agrees, at its own expense, to execute, acknowledge, deliver and cause to be duly filed all such further documents, financing statements, agreements and instruments and take all such further actions as Lender may from time to time reasonably request to better assure, preserve, protect and perfect the security interest in the IP Collateral granted pursuant to this Agreement and the rights, remedies and powers created hereby or the validity or priority of such security interest, including the payment of any fees and taxes required in connection with the execution and delivery of this Agreement, the granting of the security interest and the filing of any financing statements or other documents in connection herewith or therewith.

SECTION 13. Termination; Release of IP Collateral. Except for those provisions which expressly survive the termination thereof, this Agreement and the security interest granted herein and therein shall terminate when all Obligations and Guaranteed Obligations have been indefeasibly paid and satisfied in full, at which time Lender shall execute and deliver to Grantor, at Grantor's expense, all UCC termination statements, releases and similar documents that Grantor shall reasonably request to evidence such termination; provided, however, that (i) Lender shall not be required to execute any such document on terms which, in its reasonable opinion, would, under applicable Law, expose Lender to liability or entail any adverse consequence other than the release of such Liens without recourse or warranty, and (ii) the Loan Agreement, this Agreement, and the security interest granted herein shall be reinstated if at any time payment, or any part thereof, of any Obligation or any Guaranteed Obligation is rescinded or must otherwise be restored by Lender upon the bankruptcy or reorganization of Grantor. Any execution and delivery of termination statements, releases or other documents pursuant to this SECTION 13 shall be without recourse to, or warranty by, Lender.

SECTION 14. Choice of Laws. THIS AGREEMENT AND ALL CLAIMS WITH RESPECT THERETO SHALL BE GOVERNED BY THE LAWS OF THE STATE OF CONNECTICUT, WITHOUT GIVING EFFECT TO ANY CONFLICT OF LAW PRINCIPLES EXCEPT FEDERAL LAWS RELATING TO NATIONAL BANKS.

SECTION 15. Waiver of Prejudgment Remedies. EACH PARTY HERETO EXPRESSLY ACKNOWLEDGES THAT THIS AGREEMENT AND EACH TRANSACTION RELATED TO IT IS A "COMMERCIAL TRANSACTION" WITHIN THE MEANING OF CHAPTER 903a OF THE CONNECTICUT GENERAL STATUTES, AS AMENDED. GRANTOR HEREBY VOLUNTARILY AND KNOWINGLY WAIVES ANY AND ALL RIGHTS WHICH ARE OR MAY BE CONFERRED UPON IT UNDER CHAPTER 903a OF SAID STATUTES (OR ANY OTHER FEDERAL OR STATE LAW AFFECTING PREJUDGMENT REMEDIES) TO ANY PRIOR NOTICE OR PRIOR HEARING OR PRIOR COURT ORDER OR THE POSTING OF A BOND PRIOR TO LENDER OBTAINING A PREJUDGMENT REMEDY. GRANTOR ACKNOWLEDGES THAT IT HAS BEEN ADVISED BY COUNSEL OF ITS CHOICE OR HAS HAD THE OPPORTUNITY TO RETAIN COUNSEL OF ITS CHOICE WITH RESPECT TO THIS TRANSACTION AND THIS AGREEMENT.

SECTION 16. Counterparts; Execution. This Agreement may be executed in counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract. This Agreement shall become effective when Lender has received counterparts bearing the signatures of all parties hereto. Delivery of a signature page of this Agreement by telecopy or other electronic means (e.g. PDF) shall be effective as delivery of a

manually executed counterpart of this agreement. Any electronic signature, contract formation on an electronic platform and electronic record-keeping shall have the same legal validity and enforceability as a manually executed signature or use of a paper-based recordkeeping system to the fullest extent permitted by applicable Law.

SECTION 17. Amendment and Restatement. This Agreement amends and restates in its entirety that certain Intellectual Property Security Agreement dated April 27, 2018 (as amended, supplemented or otherwise modified from time to time, the "Prior Agreement"), made by Borrower, BD Productions, 757 Film Acquisition and Screen Media in favor of Lender. Grantors acknowledge, agree and understand that (a) the obligations of Grantors as evidenced by the Prior Agreement shall continue in full force and effect, as amended and restated in their entirety by this Agreement, all of such obligations being hereby ratified and confirmed by Grantors; (b) any and all Liens, pledges, assignments and security interests in securing Grantors' obligations under the Prior Agreement shall continue in full force and effect, are hereby ratified and confirmed by Grantors, and are hereby acknowledged by Grantors to secure, among other things, all of Grantors' obligations to Lender under this Agreement with the same priority, operation and effect as that relating to the obligations under the Prior Agreement; and (c) nothing herein contained shall be construed to extinguish, release, or discharge, or constitute, create, or effect a novation of, or an agreement to extinguish, the obligations of Grantors with respect to the obligations originally described in the Prior Agreement or any of the Liens, pledges, assignments and security interests securing such obligations.

SECTION 18. "Continuing" Event of Default. An Event of Default shall be deemed to be "continuing" for all purposes of this Agreement and each of the other Loan Documents, notwithstanding any purported curing of such Event of Default, unless, prior to the receipt by Grantor of a notice from Lender stating that Lender shall have elected to accelerate the Obligations and/or the Guaranteed Obligations, Grantor shall have cured such Event of Default to the satisfaction of Lender and so notified Lender and Lender shall have accepted such cure in writing or Lender shall have waived such Event of Default in writing.
