AMENDED AND RESTATED  
ARTICLES OF INCORPORATION

**MAD CITY WINDOWS & BATHS, INC.**

The undersigned, acting as incorporator of a corporation under the Wisconsin Business Corporation Law (Chapter 180 of the Wisconsin Statutes) and specifically for the purpose of forming a Wisconsin statutory close corporation under sec. 180.1801 thereof, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Mad City Windows & Baths, Inc.

SECOND: The period of its existence is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in any lawful activity within the purposes for which corporations may be organized under the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 9,000 shares consisting of one class only, designated as "common stock" with a par value of \$0.01 per share. The stock may be issued from time to time for such consideration as may be fixed by the shareholders.

FIFTH: Pursuant to sec. 180.1821 of the Wisconsin Statutes, the corporation hereby elects not to have a Board of Directors.

SIXTH: The address of the Registered Office of the corporation is 5020 Voges Road, Madison, Wisconsin 53718, and the name of its Registered Agent at such address is Cory B. Sturman.
