
ASSIGNMENT OF TRICON INTELLECTUAL PROPERTY

KNOW ALL MEN BY THESE PRESENTS that pursuant to that certain Asset Purchase Agreement (the "Agreement") dated as of August 25, 2008, by and among TRICON METALS & SERVICES, INC., an Alabama corporation ("Tricon"), AMY F. CASHIO, an Alabama resident ("A Cashio"), AMY F. CASHIO 2008 GRANTOR RETAINED ANNUITY TRUST, an Alabama trust ("Cashio Trust"), CYNTHIA F. RHODEN, an Alabama resident ("C Rhoden"), CYNTHIA FERGUSON RHODEN 2008 TEN-YEAR TRUST, an Alabama trust ("Rhoden Trust"), J. RICHARD CASHIO, an Alabama resident ("R Cashio"), GRANT J. MURPHY, JR., an Alabama resident ("Murphy"), and JOEY PIZZITOLA, an Alabama resident ("Pizzitola") (A Cashio, Cashio Trust, C Rhoden, Rhoden Trust, R Cashio, Murphy and Pizzitola are hereinafter collectively referred to as "Shareholders", and individually without reference to a particular individual, "Shareholder"), and KENNAMETAL ACQUISITION CORP., a Delaware corporation ("Buyer") and KENNAMETAL INC., a Pennsylvania corporation ("Kennametal"), and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Tricon hereby transfers and assigns to Buyer from and after the date hereof all of the right, title and interest in and to and all their Tricon Intellectual Property and the rights and assets associated therewith the operation of the Business.



In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.
